## **January to November Fiscal Deficit at P272.5 Billion**

**21 December 2009, Manila, Philippines:** The National Government registered a deficit in November amounting to P6.4 billion. The January to November fiscal deficit of the National Government reached P272.5 billion.

### **Revenue Performance**

Revenue collections reached P1,021.7 billion for the period January to November 2009. Actual collections were recorded at P681.9 billion for BIR and P201.4 billion for BOC. The Bureau of the Treasury income was recorded at P60.5 billion or a growth of 11% compared to the same period last year while collections from other offices was recorded at P77.8 billion.

Revenue collections reached P96.3 billion for the month of November. Actual collections for the month were recorded at P70.0 billion for BIR, P17.5 billion for BOC. Bureau of the Treasury income and collections from other offices for the month were recorded at P4.2 billion and P4.7 billion, respectively.

### **Expenditures**

For January to November 2009, total disbursements amounted to P1,294.2 billion, 13% higher than the comparable disbursements in 2008. Excluding interest payments, total disbursements increased by 17%. Actual disbursements in November amounted to P102.7 billion.

### **Primary Surplus/(Deficit)**

Netting out the interest payments in the expenditures, the National Government recorded a primary surplus for the month of November amounting to P4.3 billion. Cumulatively, the primary deficit reached to P12.4 billion for January to November.
