

INVITATION TO APPLY FOR ELIGIBILITY AND TO BID

The Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invites suppliers to apply for eligibility and to bid for the Supply and Installation of Computer Anti-Virus (Latest Version) with Console Management.

Approved Budget for the Contract (ABC) : Php900,000.00 inclusive of all applicable taxes, e.g., VAT

Delivery Schedule : Forty Five (45) working days after receipt of Notice to Proceed

Prospective bidders should have the experience in supplying the goods within the last ten (10) years with an amount of at least 50% of the proposed goods for bidding and must at least meet the minimum technical specifications/requirements of the goods to be procured as stated in the Terms of Reference (TOR)/Instructions to Bidders (ITB). The TOR/ITB can be obtained from the Office of the BAC Secretariat.

The Eligibility Check/Screening as well as the Preliminary Examination of Bids shall use the non- discretionary "pass/fail" criteria.

All particulars relative to Eligibility Statement and Screening, Bid Security, Performance Security, Pre-Bidding Conference, Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of R.A. 9184 and its Implementing Rules and Regulations (IRR).
