

## **INVITATION TO APPLY FOR ELIGIBILITY AND TO BID**

The Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invites suppliers to apply for eligibility and to bid for the Renovation of the Cash and Custodial Division Office of the Bureau of the Treasury.

**Approved Budget for the Contract (ABC) :** Php975,000.00 inclusive of all applicable taxes, e.g., VAT

**Delivery Schedule :** Sixty (60) calendar days from receipt of Notice to Proceed

### **SCOPE OF WORK :**

**STAGE I :** Mobilization/demobilization and Installation of new 0.60 x 0.60 acoustic boards and main/cross tee-runners for ceiling.

**STAGE II :** Installation of new 0.60 x 1.20 mirrorized aluminum louver with new 36 watts fluorescent lamp for lighting.

**STAGE III :** Re-painting of concrete walls, perimeter plywood walls, concrete waffle type ceiling, the steel louver aircon ducts and re-varnishing of some wooden walls including re-buffing works of marble wall surface.

Prospective bidders must have at least five (5) years experience in supplying the goods/services to be bid. The amount of completed contract, singly or an aggregate of three (3) completed contracts that is similar to the goods to be bid, must be at least 50% of the approved budget of the proposed goods for bidding and must at least meet the minimum requirements of the goods/services to be procured as stated in the Technical Specifications/Instructions to Bidders (ITB) of the bidding documents. The bidding documents can be obtained from the Office of the BAC Secretariat.

The Eligibility Check/Screening as well as the Preliminary Examination of Bids shall use the non- discretionary “pass/fail” criteria.

All particulars relative to Eligibility Statement and Screening, Bid Security, Performance Security, Pre-Bidding Conference, Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of R.A. 9184 and its Implementing Rules and Regulations (IRR).
