

## **INVITATION TO APPLY FOR ELIGIBILITY AND TO BID**

The Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invites suppliers to apply for eligibility and to bid for the Supply and Installation of Network Monitoring System.

**Name of the Project : SUPPLY AND INSTALLATION OF NETWORK MONITORING SYSTEM**

**Approved Budget for the Contract (ABC) :** Php3,088,800.00 inclusive of all applicable taxes

**Delivery Schedule :** Thirty (30) calendar days from receipt of Notice to Proceed

### **Scope of Work:**

A. Supply and installation of the following:

1. Network Monitoring Software – 1000 User Licenses
2. Network Monitoring Server – 1 unit
3. Network Switch (Managed) – one (1) unit 24 auto-sensing 10/100/1000 ports

B. User training to be conducted by a Certified Engineer.

C. Documentation must be customized for BTr (Installation and Administration Procedures)

Prospective bidders must have at least fifteen (15) years experience in IT business. The amount of completed contract, singly or an aggregate of two (2) completed contracts that is similar to the goods/services to be bid, must be at least 50% of the approved budget of the proposed goods/services for bidding and must at least meet the minimum requirements of the goods/services to be procured as stated in the Technical Specifications/Instructions to Bidders (ITB) of the bidding documents. The bidding documents can be obtained from the Office of the BAC Secretariat on the place and dates as mentioned below.

The Eligibility Check/Screening as well as the Preliminary Examination of Bids shall use the non- discretionary “pass/fail” criteria.

All particulars relative to Eligibility Statement and Screening, Bid Security, Performance Security, Pre-Bidding Conference, Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of R.A. 9184 and its Implementing Rules and Regulations (IRR).
