

INVITATION TO APPLY FOR ELIGIBILITY AND TO BID

The Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invites suppliers to apply for eligibility and to bid for the Supply of Labor and Materials for the Replacement of Lighting System along Hallways of 2nd, 3rd, 4th and 6th Floors of the Palacio del Gobernador from Non-Reflectorized Fluorescent Housing to Reflectorized Diffuser Casing using 36 Watts Fluorescent Tubes.

Name of the Project : SUPPLY OF LABOR AND MATERIALS FOR THE REPLACEMENT OF LIGHTING SYSTEM

Approved Budget for the Contract (ABC) : Php600,000.00 inclusive of all applicable taxes

Delivery Schedule : Thirty (30) working days from receipt of Notice to Proceed

Scope of Work:

- a. Dismantling and removal of old non-reflectorized fluorescent housing.
- b. Installation of new reflectorized diffuser using two pieces 36w fluorescent tubes.
- c. Repair/rehabilitation/replacement of affected/damaged acoustic boards and t-runners of ceiling along hallways.
- d. Installation of new acoustic boards with cross-tee runners for portion of condemned lights.

Prospective bidders must have at least five (5) years experience in the business. The amount of completed contract, singly or an aggregate of two (2) completed contracts that is similar to the goods/services to be bid, must be at least 50% of the approved budget of the proposed goods/services for bidding and must at least meet the minimum requirements of the goods/services to be procured as stated in the Technical Specifications/Instructions to Bidders (ITB) of the bidding documents. The bidding documents can be obtained from the Office of the BAC Secretariat on the place and dates as mentioned below.

The Eligibility Check/Screening as well as the Preliminary Examination of Bids shall use the non- discretionary “pass/fail” criteria.

All particulars relative to Eligibility Statement and Screening, Bid Security, Performance Security, Pre-Bidding Conference, Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of R.A. 9184 and its Implementing Rules and Regulations (IRR).
