

## **INVITATION TO APPLY FOR ELIGIBILITY AND TO BID**

The Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invites suppliers to apply for eligibility and to bid for the Supply of Labor and Materials for the Re-Painting of Waffle Ceiling at the 6<sup>th</sup> Floor of the Palacio del Gobernador.

**Name of the Project : SUPPLY OF LABOR AND MATERIALS FOR THE RE-PAINTING OF WAFFLE CEILING**

**Approved Budget for the Contract (ABC) : Php898,000.00 inclusive of all applicable taxes**

**Delivery Schedule : Sixty (60) working days from receipt of Notice to Proceed**

**Scope of Work:**

- a. Mobilization/demobilization for painting works of all waffle ceiling at the 6<sup>th</sup> floor.
- b. Painting with three (3) coatings white latex paint at all waffle ceiling and painting of flat wall white at the upper side of wooden walls including air-conducts louvers.

Prospective bidders must have at least five (5) years experience in the business. The amount of completed contract, singly or an aggregate of two (2) completed contracts that is similar to the goods/services to be bid, must be at least 50% of the approved budget of the proposed goods/services for bidding and must at least meet the minimum requirements of the goods/services to be procured as stated in the Technical Specifications/Instructions to Bidders (ITB) of the bidding documents. The bidding documents can be obtained from the Office of the BAC Secretariat on the place and dates as mentioned below.

The Eligibility Check/Screening as well as the Preliminary Examination of Bids shall use the non- discretionary “pass/fail” criteria.

All particulars relative to Eligibility Statement and Screening, Bid Security, Performance Security, Pre-Bidding Conference, Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of R.A. 9184 and its Implementing Rules and Regulations (IRR).
