**Bid Bulletin No. 06 - 2010**

July 7, 2010

This Bid Bulletin is issued to amend the following provisions of the *Bidding Documents* for the *Procurement of Two (2) Units of New Asian Utility Vehicles (AUV)*:

- 1) First paragraph of *Invitation to Bid*, which describes the vehicles to be procured as “Asian Utility Vehicles” (AUV) be changed to “Crossover Utility Vehicles” (CUV) so that the brief description of the project be renamed as “Procurement of Two (2) Units of New Crossover Utility Vehicles (CUV)” in consonance with the **Budget Circular No. 2010-2** issued by Department of Budget and Management on March 1, 2010 entitled “*Guidelines on the Acquisition and Use of Government Motor Vehicles*”, which among others, reclassified four-wheel enclosed vehicles having dual side doors, and a fifth rear door or lift-up tailgate as “Crossover Utility Vehicles” (CUV).”
- 2) Item 3 of schedule of activities of the *Invitation to Bid*, which states “Submission of and Opening of Bids, Rm. 401 Palacio del Gobernador, Intramuros, Manila” be changed to “Prospective bidders may submit their bids to the Office of Secretariat, BTr-BAC, Rm. 401 Palacio del Gobernador, Gen. Luna Street corner A. Soriano Avenue, Intramuros, Manila until 12:00 noon of July 12, 2010. Bids submitted shall be opened on July 12, 2010 at 1:00 P.M. at the Office of the Deputy Treasurer of the Philippines, Rm. 401 Palacio del Gobernador, Gen. Luna Street corner A. Soriano Avenue, Intramuros, Manila.”
- 3) Second paragraph of Section 2 of Bid Data Sheet, which states “The name of the Project is Procurement of two (2) units of new AUV vehicles” be changed to “The name of the project is procurement of two (2) units of new Crossover Utility Vehicles (CUV).”
- 4) Section 21 of *Bid Data Sheet*, which states “The deadline for submission of bids is July 12, 2010 at 1:00 P.M.” be changed to “The deadline for submission of bids is until 12:00 noon of July 12, 2010.”
- 5) Section 17.3 of *Special Conditions of the Contract*, which states that “One (1) year after the acceptance by the Procuring Entity of the delivered Goods” be reworded as “Three (3) years from the date of acceptance by the Procuring Entity of the delivered vehicles or before the same reaches 100,000.00-Kilometer reading, whichever comes first.”
- 6) Sections 17.4 and 17.5 of *Special Conditions of the Contract*, which states “The period for correction of defects in the warranty period is one (1) month” be changed to “The period for correction of the defects should be the soonest possible time based on reasonable standards.”

All bids shall be submitted in the Prescribed Forms attached hereto as sample forms.
