**INVITATION TO BID**

The Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invites interested bidders to apply for eligibility and to bid for the Supply, Delivery and Installation of Data Center Auxiliary Equipment for Power Management System, Including Design, Supply and Installation of Related Electrical Requirements for the Auxiliary Equipment and Data Center Facility Maintenance Services.

**Approved Budget for the Contract (ABC) :** Php3,600,000.00 inclusive of all applicable taxes

**Delivery Schedule :** Ninety (90) Calendar Days from receipt of Notice to Proceed

Prospective bidders must be an ICT company with multi-experience in different fields of ICT, Electro-Mechanical Engineering and Electrical Engineering disciplines with experience in the Data Center Design, Installation and Configuration of Data Center Components and with at least fifteen (15) years experience in the IT business. The amount of the single largest completed contract that is similar to the services to be bid for the past ten (10) years, must be at least 50% of the approved budget of the proposed services for bidding and must at least meet the minimum requirements of the services to be procured as stated in the Technical Specifications/Instructions to Bidders (ITB) of the bidding documents. The bidding documents can be obtained from the Office of the BAC Secretariat.

The Eligibility Check/Screening as well as the Preliminary Examination of Bids shall use the non- discretionary “pass/fail” criteria.

All particulars relative to Eligibility Statement and Screening, Bid Security, Performance Security, Pre-Bidding Conference, Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of the Revised Implementing Rules and Regulations (IRR) of R.A. 9184.
