## INVITATION TO BID

The Bureau of the Treasury (BTr), through its Bids and Awards Committee (BAC), invites interested suppliers to apply for eligibility and to bid for the supply and delivery of two (2) units of Asian Utility Vehicles (AUV) with locally-manufactured chassis and body with the following specifications:

Prospective bidders must have at least five (5) years experience in supplying the goods to be bid with an amount of at least 50% of the approved budget of the proposed goods for bidding and must at least meet the minimum requirements of the goods to be procured as stated in the Technical Specifications/Instructions to Bidders (TS/ITB) of the bidding documents. The bidding documents can be obtained from the Office of the BAC Secretariat, 3<sup>rd</sup> Floor, Room 303, Palacio del Gobernador, Intramuros, Manila.

The Eligibility Check/Screening as well as the Preliminary Examination of Bids shall use the non- discretionary “Pass/Fail” criteria.

Other terms and conditions in relation hereto are as indicated in the TS/ITB and Bid Data Sheet.

All particulars relative to Eligibility Check/Screening, Bid Security, Performance Security, Pre-Bidding Conference, Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of RA 9184 and its Revised Implementing Rules and Regulations.
