Bid forms/bidding documents are available at the PSMD through the DC's Secretariat, Room 604, 6<sup>th</sup> Floor, PDGB. Said documents shall be issued upon payment of non-refundable one tenth percent of the total minimum bid price set by the Bureau (but should not be less than P100.00) at the Cash Custodial Division, Ground floor of the same building. The authority to accept payment (ATAP) should be secured first from the Accounting Division, 6<sup>th</sup> Floor before payment of the P100.00 bid forms.

Sealed bids in the prescribed form, in three (3) copies, shall be submitted to the Chairman of the Disposal Committee through its Secretariat together with the corresponding Bid Bond Deposit in the amount of P10,931.75 (either in cash or Manager's Check), equivalent to at least ten percent (10%) of the minimum bid price set by the Bureau.

Last day of submission of bids will be on February 15, 2012, at 2:00 in the afternoon.

Bids will be opened publicly, on February 15, 2012, at 2:30 in the afternoon, at the Conference Room, Office of the undersigned at room 201, 2<sup>nd</sup> Floor, Palacio del Gobernador Building (PDGB), Intramuros, Manila, in the presence of COA representative. Bidders may attend the said bid opening.
