Prospective bidders should have the experience in supplying the goods within the last 3 years with an amount of at least 50% of the proposed goods for bidding and **must at least meet the minimum requirements of the goods to be procured as stated in the Terms of Reference (TOR) /Instructions to Bidders (ITB)**. The TOR/ITB can be obtained from the Office of BAC Secretariat.

The Eligibility Check/ Screening as well as the Preliminary Examination of Bids shall use non-discretionary “pass/fail” criteria.

The bidding documents and forms shall be available on **July 25 to August 8, 2007** at the Office of BAC Secretariat, Rm. 409 located at the 4/F of Palacio del Gobernador Bldg., Intramuros, Manila, upon payment of a **non-refundable amount equivalent to 0.1% of the ABC per lot but not less than P1,000.00**.

The Pre-bidding Conference will be held on **August 9, 2007, 2:00 P.M.** at the Conference Room of Atty. Gisela F. Lood, BAC Chairperson.

All particulars relative to Eligibility Statement and Screening, Bid Security, Performance Security, Pre-Bidding Conference, Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by pertinent provisions of R.A. 9184 and its Implementing Rules and Regulations.

The BTr BAC reserves the right to reject documents which do not comply with the requirements and reject any and all bids, annul the bidding process, or not award the contract, without thereby incurring any liability to the affected bidder or bidders.

The BAC assumes no responsibility whatsoever to compensate or indemnify bidders for expenses incurred in the preparation of the bid.
