#### C. Reminders:

1. Ensure that correct NRoSS Account Numbers are inputted at the PDEx Trading Platform to avoid invalid trades.

When entering trades in the PDS trading platform kindly observe the following:

a. when entering the NRoSS Account number, remember to use the delimiters:

'P=' and '#' to identify the entered NRoSS account number on the Ref Fields.

b. Valid format:

P=NRoSSAccountNumber#

'P=' denotes the start delimiter of the NRoSS Account Number field, followed by alphanumeric characters NRoSSAccountNumber> followed by '#' to denotes the end delimeter of the NRoSS Account.

- c. Example:
  - a. For eight(8) alphanumeric character NRoSS AccountsP=XXXXYYY0#

Where: 'P=' is the start delimiter
'XXXXYYY0' is the NRoSS Account Number
'#' is the end delimiter

b. For fifteen(15) alphanumeric character NRoSS AccountsP=XXXXYYY9abcde99#

Where: 'P=' is the start delimiter
'XXXXYYY9abcde99' is the NRoSS Account Number
'#' is the end delimiter

- 2. Proper authorization shall be made at the PDS Gateway so trades could be transmitted to NRoSS for further authorization.
- 3. For authorization at NRoSS, the maker and the checker shall approve the transaction (four eyes check).
- 4. Ensure sufficient balance of test ISINs in the NRoSS Account.
- 5. Refer to the MWT-7 Guide (<a href="http://www.treasury.gov.ph/?page\_id=9926">http://www.treasury.gov.ph/?page\_id=9926</a>) to ensure that all test scenarios are performed.
