Description

PREVENTIVE MAINTENANCE SERVICES OF TWO (2) UNITS GENERATOR SETS (1125/800 KVA) OF THE AYUNTAMIENTO BUILDING

BRIEF DESCRIPTION:

Preventive Maintenance Services for the generator sets greatly reduces the risk that an internal or ancillary component malfunction will cause the generator to produce insufficient power. It is intended to detect normal life-cycle deterioration of components within the system and replace those components before they fail.

DURATION OF CONTRACT

One (1) year

SCOPE OF WORK AND SERVICES

A. Exhaust System - with generator set operating, inspect the entire exhaust system including the exhaust manifold, muffler and exhaust pipe. Check for leaks at all connections, welds, gasket and joints, and make sure that the exhaust pipes are not heating surrounding areas excessively. Repair any leaks immediately.

B. Fuel System - With the generator set operating, inspect the fuel supply lines, return lines, filters and fittings for cracks or abrasions. Make sure that all lines are not rubbing against anything that could cause eventual breakage. Repair any leak or alter line routing to eliminate immediately.

C. DC Electrical Systems - check the terminals on the starting batteries fro clean and tight connections. Loose or corroded connections create resistance which can hinder starting.

D. Engine - monitor fluid levels, oil pressure and coolant temperature frequently. Most engine problems give an early warning. Look and listen for changes in engine performance, sound, or appearance that will indicate that service of repair is needed. Be alert for misfires, vibration, excessive exhaust smoke, and loss of power or increase in oil or fuel consumption.

OTHER RESPONSIBILITIES OF THE SUPPLIER/CONTRACTOR

A. Must have ten (10) years existence in the business.

B. The Contractor shall submit submit the following requirements:

*DTI/SEC registration certificate

*Mayor's Permit

*PhilGEPS Registration Certificate
