THE REGISTRY

It is understood that RoSS is the official Registry of Scripless Securities maintained and administered by the Bureau of the Treasury, Department of Finance.

It is understood that all government securities floated/originated by the National Government under its scripless policy are recorded in the official Registry in the name of the Government Securities Eligible Dealer (GSED) by virtue of the auction award made by the Auction Committee created under DOF Order No. 141-95, as amended.

It is understood that the GSED shall maintain its inventory of scripless government securities in a Principal Securities Account in RoSS.

It is understood that subsequent transfer of ownership or encumbrance on the scripless securities out of the Principal Securities Account of a GSED shall be recorded in RoSS into the Securities Account of the counterparty GSED or Client Securities Account of a GSED.

As a buyer of scripless government securities this Institution/Person hereby applies to open its own Client Securities Account with RoSS to ensure its title to said securities is officially recorded in its name.

It is understood that the Bureau of the Treasury shall keep the absolute confidentiality of the Registry in accordance with Republic Act No. 1405.

SECURITIES ACCOUNT

All acquisition of scripless government securities by this Institution/Person shall be recorded in the Client Securities Account hereinafter opened and maintained. Likewise, any securities pledged to this Institution/Person.

In the event that this Institution/Person encumbers or conveys absolutely its ownership over the scripless recorded by RoSS in its name, such encumbrance/conveyance shall be accordingly recorded in RoSS by this Institution/Person through its GSED.

This serves as the formal application for a Client Securities Account in this Institution/Person's name.

SETTLEMENT ACCOUNT

CLEARING AND SETTLEMENT

While clearing the securities will be the function of RoSS., settlement of the same trade shall be done by and between this Institution/Person and its GSED/BSP.

STATEMENT OF ACCOUNT

It is understood that RoSS will provide this Institution/Person a Statement of Account whenever a transaction is recorded in its Client Securities Account. This may either be daily or monthly.

COUPONS AND REDEMPTION VALUES

Any amount representing coupons or redemption value of securities in this Institution/Person's Client Securities Account shall be credited in the GSED's Settlement Account with BSP.
