As discussed in the Participant Briefing held on 30 October 2017, the NRoSS Project Team will be conducting another data migration dry run and another cycle of Market Wide Testing (MWT) in order to ensure the successful implementation of the NRoSS.

- Authorized representatives shall receive an email from the NRoSS Helpdesk. The
  email shall contain a link and user credentials that the authorized representative shall
  use in downloading the SOAs and the List of RoSS and Subregistry accounts with
  corresponding NRoSS Account Numbers.
- If no issue is reported by the Participant's authorized representative/s on or before 22
   November (Wednesday), 3pm, this will mean that the NRoSS Account Numbers of the Participants including their Sponsored clients are in order.
- 4. NRoSS Account Numbers assigned to RoSS and Sub-registry Accounts during the dry run are <u>for test purposes only</u> and should not be construed as the final NRoSS Account Numbers of the Participants/Sponsored clients. Final NRoSS Account Numbers will be determined during the actual cut-over date preceding the system Go Live! to be announced by the BTr.
