

# Common Findings/Results:


- Comparison of NRoSS accounts against existing inventory of accounts and ISINs indicates both are matched
- Missing Non-Tradeable holdings are classified under Regulatory compliance accounts




### **Business Process Model for Secondary Market Trade**




### A. Current Business Process

### Guidelines:

- 1. Participants will 'authorize' the trade settlement in NRoSS
- 2. Participants should enter trades for their;
  - a. own account
  - b their sponsored accounts
- 3. REMINDER:

Client account Debit Authorization Arrangement with settlement bank must be in place.

#### Business process scenario:

- 1. Trading Participants entered buy and sell transactions in the trading platform
- 2. Trade transactions are matched and are authorized in the Trading Platform
- 3. Authorized Trade transactions are forwarded to NRoSS


II. NRoSS Enhancements | Workstation Messaging MT578 - Alledgement Message






