The Bureau of the Treasury will be transitioning to the NRoSS as the new registry system for Philippine Peso-denominated government securities (GS) effective 28 August 2018.

As the system uses web-enabled technology, it will provide all NRoSS Direct Participants with access to the various functionalities of NRoSS. Below is the new structure of the Registry Fees to be charged by the BTr:

For additional e-tokens, payment shall be made prior to release thereof via a one-off charge at NRoSS.

BTr reserves the right to charge such other fees (e.g., administrative fees) and expenses incurred for or on account of a Registry Accountholder or fees for delayed payment or non-compliance of the Rules of the Registry and other related agreements.

We shall notify you of any adjustment in fees through the BTr website (www.treasury.gov.ph) ten (10) banking days prior to its effectivity.
