INVITATION TO BID

The Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invites PhilGEPS registered suppliers/contractors to apply for eligibility and to bid for the Procurement of Supply, Labor, Material, Delivery and Installation of Office Signage at Regional Offices and Provincial Offices of the Bureau of the Treasury, with a total Approved Budget for the Contract (ABC) of **Four Million Pesos (Php4,000,000.00)** inclusive of all applicable taxes. Bids received in excess of the ABC shall be automatically rejected at the bid opening.

Prospective bidders must be operating in the Philippines for the past three (3) years in the supply and installation of signages. Prospective bidders must have completed within the past three (3) years a single largest contract similar to the goods to be bid with a contract price equivalent to at least 50% of the approved budget of the proposed goods for bidding and must at least meet the minimum requirements of the goods to be procured as stated in the Technical Specifications/Instructions to Bidders (ITB) of the bidding documents.

A pre-registration will be conducted to prospective bidders who wish to attend the scheduled bidding activities. Only those who registered will be provided an invitation/link for the scheduled Pre-Bid Conference. Please refer to the pre-registration link:

The bidding documents may be obtained from the Office of the BAC Secretariat on the place and dates mentioned below upon payment of a non-refundable amount Four Thousand Pesos (Php 4,000.00) for the Procurement of Supply, Labor, Material, Delivery and Installation of Office Signage at Regional Offices and Provincial Offices of the Bureau of the Treasury.

Payment shall be through deposit to the Trust Fund Account of the BAC at the Land Bank of the Philippines with the following details:

The Bidders shall submit and send through email at bac@treasury.gov.ph a scanned or screen captured copy of the Transaction Receipt/Deposit Slip as their proof of payment at least three (3) days before the date of bid opening.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the fee for the Bidding Documents not later than the submission of their bids.

The *electronic* submission of bidding documents shall be made only to the official email: e-bids@treasury.gov.ph. Only pre-registered bidders who have received meeting invitation link and with submitted proof of payment of bidding documents (e.g. electronic payment system transaction receipt, validated bank deposit slip) will be allowed to submit their bids

The Eligibility Check/Screening as well as the Preliminary Examination of Bids shall use the non- discretionary "pass/fail" criteria. Failure to submit the required document under the bidding

documents or the submission of a document which does not comply with the legal formalities shall be rated “failed”.

All particulars relative to Eligibility Statement and Screening, Bid Security, Performance Security, Pre-Bidding Conference, Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of R.A. 9184 and its Revised Implementing Rules and Regulations (RIRR).
