5. The bid offer together with the bid bond in a form of cash, equivalent to 10% of the bid offer/ bid price shall be submitted in a sealed envelope and shall be addressed to the Chairman of the Disposal Committee through the Disposal Committee Secretariat.

6. A bidder may withdraw a bid tender before the opening of bids.
7. Last day of submission of bid offer will be on November 26, 2020, 1:00 P.M.
8. The sealed bid offers will be opened on November 27, 2020, 9:30 A.M. through Google Meet. Participating bidders are encouraged to have a google meet app and send their respective gmail accounts to the Disposal Committee Secretariat to be able to virtually witness the opening of bids.
9. Bid price should be in words and in figures. In case of discrepancy between price in words and in figures, the former shall prevail. Bids below the minimum bid price will be automatically disqualified. The bidder who offers the highest amount of bid shall be declared the winner.
10. Winning bidders may pay their respective bid offers upon withdrawal of the items which shall be made within five (5) working days from the date of Notice of Award. The bidder would not be able to withdraw the item until and unless bid is fully paid. In case of failure of full payment within the prescribed period, the award/contract may be cancelled and may be awarded to the next highest bidder.
11. Claim/withdrawal of the item shall be made during official government working hours only and upon full payment as evidenced by an official receipt and should be made within five (5) working days thereafter. It should be made within the period fixed by the DC but should not be more than 30 days after awarding. All expenses incidental to the withdrawal of the property shall be borne by the awardee. Failure on the part of the awardee to claim the property within the stipulated period shall have the effect of cancellation of the award/contract.




12. Considering that the subject unserviceable properties and waste/junk materials are all secondhand and that the SALE is on "AS IS WHERE IS" basis, the Bureau shall not be liable for any defect found after the SALE of the items.
13. The Bureau reserves the right to reject any or all proposals submitted and accept that which is most advantageous to the government, without any obligation, liability or need of reimbursement for costs incurred by interested parties.
