RESOLUTION NO. 35 - 2020

RECOMMENDING THE CHANGE OF PROCUREMENT MODALITY FOR THE PROCUREMENT OF SUPPLY OF LABOR, MATERIALS, DELIVERY AND INSTALLATION OF OFFICE SIGNAGES AT REGIONAL OFFICES AND PROVINCIAL OFFICES OF THE BUREAU OF THE TREASURY

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee, invited prospective bidders to apply for eligibility and to bid for the Procurement of Supply of Labor, Materials, Delivery and Installation of Office Signages at Regional Offices and Provincial Offices of the Bureau of the Treasury with an Approved Budget for the Contract (ABC) of Four Million Pesos (Php4,000,000.00), inclusive of all applicable taxes;

WHEREAS, on September 17, 2020, the Invitation to Bid was posted through the Philippine Government Electronic Procurement System (PhilGEPS) and the BTr website;

WHEREAS, on September 24, 2020, three (3) prospective bidders, namely, Smartsign Advertising Inc., Dplus Sign Advertising Corporation and Anglowealth Enterprises attended the scheduled Pre-Bidding Conference;

WHEREAS, on September 29, 2020, Supplemental Bid Bulletin No. 09-2020 was issued to modify/amend items in the Bid Documents, in response to the queries and clarifications made during the Pre-Bid Conference;

WHEREAS, during the supposed opening of bids where there was no appearance from prospective bidders, the BAC Chairperson relayed to the body that the end-user intends to cancel the public bidding and change into another modality of procurement, and instructed the BAC-Technical Working Group and End-User Group to study the possibility of doing a regionalized procurement for this project;

WHEREAS, in a Memorandum dated 30 October 2020 the end-user group requested for the cancellation of the Procurement of Supply of Labor, Materials, Delivery and Installation of Office Signages at Regional Offices and Provincial Offices of the Bureau of the Treasury, justifying that it is more beneficial and advantageous to the Bureau to decentralize the procurement for this project;

WHEREAS, the BAC Chairperson reiterated the reservation clause, as stated in the Invitation to bid.

NOW THEREFORE, the Bids and Awards Committee RESOLVED, as it hereby RESOLVES to:

- a. cancel the public bidding modality for the Procurement of Supply of Labor, Materials, Delivery and Installation of Office Signages at Regional Offices and Provincial Offices of the Bureau of the Treasury;
- b. recommend the re-bid of the Procurement of Supply of Labor, Materials, Delivery and Installation of Office Signages at Regional Offices and Provincial Offices of the Bureau of the Treasury using an alternative method of procurement which is small value procurement (SVP) to be undertaken by the Regional BAC; and
- c. recommend for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE) the foregoing findings.
