We enjoin all BTr-managed entities who are still paying their NRoSS maintenance fees through cash and check to make the necessary periodic payment on the **first business day of each month**. This is in order to avoid inconvenience in the processing of transactions resulting from the delayed and/or non-payment of the fees.

Further, as part of the Bureau's effort to streamline NRoSS-related processes, BTr-managed accounts are encouraged to nominate a settlement bank or have an NRoSS account(s) under an eligible sponsor of the BTr. As part of the Bureau's effort to promote fast and efficient collection, we enjoin all BTr-Managed Accounts to nominate a settlement bank and submit to BTr a duly accomplished Auto Debit Authorization (refer to Annex A) effective September 23, 2019. BTr shall use the said authority to charge the Regular Demand Deposit Account (RDDA) of your nominated Settlement Bank for the payment of the monthly NRoSS account maintenance fees every first business day of the month.

BTr-Managed Accounts who are unable to comply with this memorandum are required to be sponsored by an eligible sponsor of the BTr who shall create a Sponsored Client Account in NRoSS and effect securities transfer in the said account for trade and non-trade related transactions. Once sponsored by an eligible sponsor of the BTr and after the BTr-Managed NRoSS account has been closed then the entity shall no longer be required to pay the subsequent NRoSS account maintenance fees.
