CONTRACT AGREEMENT

INFOBAHN sums as may **COMMUNICATIONS, INC.** agrees to perform and deliver the "Supply and Installation of 1 Year License to Existing Backup System of the Bureau Of accordance with his/her/its The Treasury" in accepted Bid/Quotation/Proposal.
- The BUREAU OF THE TREASURY agrees to pay the above-mentioned 4. accordance with the terms of the Bidding/Accepted sum in Quotation/Proposal and procurement documents.
