CONTRACT AGREEMENT

THIS AGREEMENT made this 12th day of January 2022 between the **BUREAU OF THE TREASURY**, with office address at Ayuntamiento Building, Cabildo Street corner Andres Soriano Avenue, Intramuros, Manila 1002 (hereinafter called "the Entity") of the one part and **MAROONSTUDIOS, INC.** with office address at 115 Dr. Alejos St., San Isidro Labrador, Quezon City, Metro Manila (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids/Quotations for certain goods and ancillary services, particularly Procurement of Google Workspace Software Licenses for the Official Email of the Bureau of the Treasury and has accepted a Bid/Quotation/Proposal by the Supplier for the supply of those goods and services in the sum of APPLICABLE TAX (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

- In consideration for the sum of PHILIPPINE PESO: THREE MILLION 3. THREE HUNDRED SEVENTY-FIVE THOUSAND ONE HUNDRED TEN (PHP3,375,110.00), INCLUSIVE OF APPLICABLE TAX or such other sums as may be ascertained, MAROONSTUDIOS, INC. agrees to perform and deliver the "Procurement of Google Workspace Software Licenses for the Official Email of the Bureau of the Treasury" in accordance with his/her/its accepted Bid/Quotation/Proposal.
- The **BUREAU OF THE TREASURY** agrees to pay the above-mentioned accordance with the terms of the Bidding/Accepted sum in Quotation/Proposal and procurement documents.
