## CONTRACT AGREEMENT

THIS AGREEMENT made this 4<sup>th</sup> day of January 2022 between the **BUREAU OF THE TREASURY**, with office address at Ayuntamiento Building, Cabildo Street corner Andres Soriano Avenue, Intramuros, Manila 1002 (hereinafter called "the Entity") of the one part and **RENPHIL TRADING** with office address at Unit 10 K-Plaza 22 Gen. T De Leon Road, Karuhatan, Valenzuela City (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids/Quotations for certain goods and ancillary services, particularly One (1) Year Preventive Maintenance of the Mechanical, Electrical, Plumbing, Fire and Safety Systems of the Ayuntamiento Building for FY 2022 and has accepted a Bid/Quotation/Proposal by the Supplier for the supply of those goods and services in the sum of <u>PHILIPPINE PESO:</u> <u>SEVEN MILLION SIX</u> <u>HUNDRED FORTY-EIGHT THOUSAND THREE HUNDRED FORTY</u> (PHP7,648,340.00), INCLUSIVE OF APPLICABLE TAX (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- 2. The following documents as required by the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, *viz*.:
  - i. Philippine Bidding Documents (PBDs)<sup>1</sup>;
    - i. Schedule of Requirements;
    - ii. Technical Specifications;
    - iii. General and Special Conditions of Contract<sup>2</sup>; and
    - iv. Supplemental or Bid Bulletins, if any
  - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme<sup>4</sup> thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. <u>Winning bidder<sup>5</sup></u> <u>agrees that additional contract documents or information</u> <u>prescribed by the GPPB that are subsequently required for</u> <u>submission after the contract execution, such as the Notice to</u> <u>Proceed, Variation Orders, and Warranty Security, shall likewise</u> <u>form part of the Contract.</u>
- In consideration for the sum of <u>PHILIPPINE PESO: SEVEN MILLION SIX</u> <u>HUNDRED FORTY-EIGHT THOUSAND THREE HUNDRED FORTY</u> (PHP7,648,340.00), INCLUSIVE OF APPLICABLE TAX or such other sums as may be ascertained, <u>RENPHIL TRADING</u> agrees to perform and deliver the "One (1) Year Preventive Maintenance of the Mechanical, Electrical, Plumbing, Fire and Safety Systems of the Ayuntamiento Building for FY 2022" in accordance with his/her/its accepted Bid/Quotation/Proposal.
- 4. The **BUREAU OF THE TREASURY** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding/Accepted Quotation/Proposal and procurement documents.
