## **CONTRACT AGREEMENT**

In consideration for the sum of <a href="PHILIPPINE PESO: ONE MILLION SEVEN HUNDRED NINETY-EIGHT THOUSAND PESOS (PHP1,798,000.00), INCLUSIVE OF APPLICABLE TAX or such other sums as may be ascertained, PENITON TRADING agrees to perform and deliver the "Supply, Delivery, and Installation of Workstations and other Office Furniture for the Trust Fund Committee (TFMC) Secretariat Office at the Palacio Del Gobernador" in accordance with his/her/its accepted Bid/Quotation/Proposal.</a>
- 4. The <u>BUREAU OF THE TREASURY</u> agrees to pay the above-mentioned sum in accordance with the terms of the Bidding/Accepted Quotation/Proposal and procurement documents.
