**DECLARING FAILURE OF BIDDING AND RECOMMENDING THE RE-BID FOR THE
SUPPLY AND DELIVERY OF ONE (1) LOT OF DOCUMENT SCANNERS FOR THE
BUREAU OF THE TREASURY**

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Supply and Delivery of One (1) Lot of Document Scanners for the Bureau of the Treasury with an Approved Budget for the Contract (ABC) of Two Million Two Hundred Twenty-Six Thousand Pesos (Php2,226,000.00), inclusive of all applicable taxes;

WHEREAS, on December 14, 2021, the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and BTr website;

WHEREAS, on December 21, 2021, five (5) prospective bidders, namely, 1) Microimaging Sales and Services, Inc., 2) Pantronics International Corporation, 3) Quartz Business Products Corporation, 4) Solid Business Machines Center, Inc., and 5) Pacific Office Solutions, Inc., attended the Pre-Bidding Conference;

WHEREAS, on December 23, 2021, Supplemental Bid Bulletin No. 27 - 2021 was issued to modify/amend items in the Bid Documents, in response to the queries and clarifications made during the Pre-Bid Conference;

WHEREAS, on December 31, 2021, no bidder submitted its bids and participated in the Opening of Bids thus, the BAC is constrained to declare a failure of bidding for the Supply and Delivery of One (1) Lot of Document Scanners for the Bureau of the Treasury;

NOW THEREFORE, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

- a. declare failure of bidding for the Supply and Delivery of One (1) Lot of Document Scanners for the Bureau of the Treasury;
- b. recommend for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE) the foregoing findings; and
- c. conduct re-bidding of this project.
