**DECLARING FAILURE OF BIDDING AND RECOMMENDING THE RE-BID FOR  
THE SUPPLY AND DELIVERY OF VARIOUS IT EQUIPMENT FOR THE TRUST  
FUND MANAGEMENT COMMITTEE (TFMC) SECRETARIAT  
LOT 2 - LAPTOP**

**WHEREAS**, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Supply and Delivery of Various IT equipment for the Trust Fund Management Committee (TFMC) Secretariat Lot 2 - Laptop with an Approved Budget for the Contract (ABC) of Two Hundred Forty-One Thousand Two Hundred Pesos (Php241,200.00), inclusive of all applicable taxes;

**WHEREAS**, on March 29, 2022, the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and BTr website;

**WHEREAS**, on April 6, 2022, three (3) prospective bidders, namely, 1) DCI International I.T. Solutions & Services Corporation, 2) Infocentric Solutions Inc. and 3) Integrated Computer Systems, Inc. attended but only DCI International I.T. Solutions & Services Corporation and Integrated Computer Systems, Inc. purchased the bidding documents;

**WHEREAS**, on April 11, 2022, Supplemental Bid Bulletin No. 4(b)-2022 was issued to modify/amend items in the Bid Documents, in response to the queries and clarifications made during the Pre-Bid Conference;

**WHEREAS**, on April 19, 2022, no bidder submitted its bids and participated in the Opening of Bids thus, the BAC is constrained to declare a failure of bidding for the Supply and Delivery of Various IT equipment for the Trust Fund Management Committee (TFMC) Secretariat Lot 2 - Laptop;

**NOW THEREFORE**, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

- a. declare failure of bidding for the Supply and Delivery of Various IT equipment for the Trust Fund Management Committee (TFMC) Secretariat Lot 2 - Laptop;
- b. recommend for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE) the foregoing findings; and
- c. conduct re-bidding of this project.
