**RESOLUTION NO. 15 - 2022**

**DECLARING FAILURE OF BIDDING AND RECOMMENDING THE RE-BID FOR  
THE SUPPLY AND DELIVERY OF VARIOUS PRINTERS FOR THE BUREAU OF  
THE TREASURY (BTR) AND THE TRUST FUND MANAGEMENT COMMITTEE  
(TFMC) SECRETARIAT LOT 1 - BTR (COLORED PRINTERS)**

**WHEREAS**, the Bureau of the Treasury (BTr), through the Bids and Awards Committee, invited prospective bidders to apply for eligibility and to bid for the Supply and Delivery of Various Printers for the Bureau of the Treasury (BTr) and the Trust Fund Management Committee (TFMC) Secretariat Lot 1 - BTr (Colored Printers) with an Approved Budget for the Contract (ABC) of One Million Six Hundred Sixty-Five Thousand Pesos (Php1,665,000.00), inclusive of all applicable taxes;

**WHEREAS**, on March 29, 2022, the Invitation to bid was posted through the Philippine Government Electronic Procurement System (PhilGEPS) and the BTr website;

**WHEREAS**, on April 6, 2022, during the scheduled Pre-Bidding Conference, five (5) prospective bidders, namely, 1) Otus Copy Systems, Inc., 2) Integrated Computer Systems, Inc., 3) Gakken Philippines Inc., 4) Link Network Solutions, Inc., 5) Quartz Business Products Corporation attended but only Quartz Business Products Corporation and Integrated Computer Systems, Inc. purchased the bidding documents;

**WHEREAS**, on April 11, 2022, Supplemental Bid Bulletin No. 05(a)-2022 was issued to modify/amend items in the Bid Documents, in response to the queries and clarifications made during the Pre-Bid Conference;

**WHEREAS**, on April 19, 2022, during the scheduled Opening of Bids, two (2) bidders, Quartz Business Products Corporation and Integrated Computer Systems, Inc. submitted their bids, however, Quartz Business Products Corporation was disqualified due to its late bid submission, therefore, only the bid of Integrated Computer Systems, Inc. was opened, read, and calculated;

**WHEREAS**, pursuant to Resolution No 7-2022 dated April 19, 2022, the BAC declared Integrated Computer Systems, Inc. as the Single Calculated Bidder (SCB) and was subjected to Post-Qualification;

**WHEREAS**, the Technical Working Group (TWG) submitted their post qualification report, which was adopted by the BAC in a regular meeting on May 24, 2022;

**WHEREAS**, upon careful examination, validation and verification of all statements made and the legal, technical, and financial documents submitted by Integrated Computer Systems, Inc., the BAC found its bid as non-responsive, for its failure to submit signed original Omnibus Sworn Statement, hence, leading to its non-compliance with the requirements contained in the bidding documents;

**WHEREAS**, a Notice of Post-Disqualification was issued to Integrated Computer Systems, Inc. on May 25, 2022 which was acknowledged receipt on June 13, 2022;

**WHEREAS**, in a letter dated June 13, 2022 and received by the BAC Secretariat on the same date, Integrated Computer Systems, Inc. filed their Request for Reconsideration appealing to the committee of the approval to resubmit a signed original Omnibus Sworn Statement, which on June 16, 2022 the BAC finally resolved to deny said Request for Reconsideration;

**WHEREAS**, after due consideration and deliberation, the BAC is constrained, and thus, resolved to declare a failure of bidding for the Supply and Delivery of Various Printers for the Bureau of the Treasury (BTr) and the Trust Fund Management Committee (TFMC) Secretariat Lot 1 - BTr (Colored Printers);

**NOW THEREFORE**, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

- a. deny the Request for Reconsideration filed by Integrated Computer Systems, Inc. dated June 13, 2022;
- b. declare failure of bidding for the Supply and Delivery of Various Printers for the Bureau of the Treasury (BTr) and the Trust Fund Management Committee (TFMC) Secretariat Lot 1 - BTr (Colored Printers);
- c. recommend the re-bid of the Supply and Delivery of Various Printers for the Bureau of the Treasury (BTr) and the Trust Fund Management Committee (TFMC) Secretariat Lot 1 - BTr (Colored Printers); and
- d. recommend for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE) the foregoing findings.
