**DECLARING FAILURE OF BIDDING AND RECOMMENDING THE RE-BID FOR THE SUPPLY AND DELIVERY OF VARIOUS PRINTERS FOR THE BUREAU OF THE TREASURY (BTR) AND THE TRUST FUND MANAGEMENT COMMITTEE (TFMC) SECRETARIAT LOT 2 - TFMC (MONOCHROMATIC AND COLORED PRINTERS)**

**WHEREAS**, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Supply and Delivery of Various Printers for the Bureau of the Treasury (BTr) and the Trust Fund Management Committee (TFMC) Secretariat Lot 2 - TFMC (Monochromatic and Colored Printers) with an Approved Budget for the Contract (ABC) of One Hundred Fifty-Six Thousand Pesos (Php156,000.00), inclusive of all applicable taxes;

**WHEREAS**, on March 29, 2022, the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and BTr website;

**WHEREAS**, on April 6, 2022, five (5) prospective bidders, namely, 1) Otus Copy Systems, Inc., 2) Integrated Computer Systems, Inc., 3) Gakken Philippines Inc., 4) Link Network Solutions, Inc., 5) Quartz Business Products Corporation attended the Pre-bid Conference;

**WHEREAS**, on April 11, 2022, Supplemental Bid Bulletin No. 05(b)-2022 was issued to modify/amend items in the Bid Documents, in response to the queries and clarifications made during the Pre-Bid Conference;

**WHEREAS**, on April 19, 2022, Quartz Business Products Corporation submitted its bids and participated in the Opening of Bids, however, the bidder was disqualified due to its late bid submission, thus, the BAC is constrained to declare a failure of bidding for the Supply and Delivery of Various Printers for the Bureau of the Treasury (BTr) and the Trust Fund Management Committee (TFMC) Secretariat Lot 2 - TFMC (Monochromatic and Colored Printers);

**NOW THEREFORE**, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

- a. declare failure of bidding for the Supply and Delivery of Various Printers for the Bureau of the Treasury (BTr) and the Trust Fund Management Committee (TFMC) Secretariat Lot 2 - TFMC (Monochromatic and Colored Printers);
- b. recommend for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE) the foregoing findings; and
