DECLARING FAILURE OF BIDDING AND RECOMMENDING THE RE-BID FOR THE ENHANCEMENT AND MAINTENANCE SUPPORT SERVICES FOR VARIOUS PUBLIC FINANCIAL MANAGEMENT (PFM) APPLICATION SYSTEMS OF THE BUREAU OF THE TREASURY (BTR)

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Enhancement and Maintenance Support Services for Various Public Financial Management (PFM) Application Systems of the Bureau of the Treasury (BTr) with an Approved Budget for the Contract (ABC) of Twenty-Two Million Pesos (PHP22,000,000.00), inclusive of all applicable taxes;

WHEREAS, on October 6, 2022, the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and BTr website;

WHEREAS, on October 14, 2022, during the scheduled Pre-Bidding Conference, only one (1) prospective bidder, Incuventure Partners Corporation attended but only did not purchase the bidding documents;

WHEREAS, on October 26, 2022, no bidder submitted its bids and participated in the Opening of Bids thus, the BAC is constrained to declare a failure of bidding for the Enhancement and Maintenance Support Services for Various Public Financial Management (PFM) Application Systems of the Bureau of the Treasury (BTr);

NOW THEREFORE, the Bids and Awards Committee **RESOLVED,** as it hereby **RESOLVES** to:

- a. declare failure of bidding for the Enhancement and Maintenance Support Services for Various Public Financial Management (PFM) Application Systems of the Bureau of the Treasury (BTr);
- b. recommend for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE) the foregoing findings; and
- c. conduct re-bidding of this project.
