RESOLUTION NO. 47 - 2022

**DECLARING FAILURE OF BIDDING AND RECOMMENDING THE RE-BID FOR THE
ENHANCEMENT AND MAINTENANCE SUPPORT SERVICES FOR VARIOUS PUBLIC
FINANCIAL MANAGEMENT (PFM) APPLICATION SYSTEMS OF THE BUREAU OF THE
TREASURY (RE-BID) / ITB-35-2022-G**

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Enhancement and Maintenance Support Services for Various Public Financial Management (PFM) Application Systems of the Bureau of the Treasury (RE-BID) with an Approved Budget for the Contract (ABC) of Twenty-Two Million Pesos (PHP22,000,000.00), inclusive of all applicable taxes;

WHEREAS, on November 23, 2022, the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and BTr website;

WHEREAS, on December 1, 2022, during the scheduled Pre-Bidding Conference, two (2) prospective bidders, namely, 1) Incuventure Partners, Inc. and 2) Varco Technosolutions, Inc. attended but only Varco Technosolutions, Inc. purchased the bidding documents;

WHEREAS, on December 5, 2022 and December 6, 2022, Supplemental Bid Bulletin No. 19 - 2022 and Supplemental Bid Bulletin No. 25 – 2022, respectively, were issued to modify/amend items in the Bid Documents, in response to the queries and clarifications made during the Pre-Bid Conference;

WHEREAS, on December 13, 2022, during the scheduled Opening of Bids, only one bidder, Varco Technosolutions, Inc., submitted its bid, however, during the opening of its Technical Bid, Varco Technosolutions, Inc. failed to comply with the requirements in the Statement of Bidder's Existence and Expertise as part of the Section VII. Technical Specifications, under Part II. Bidder's Compliance, Clause No. 1.3: The bidder must have at least 1 similar contract in the last 5 years, therefore, Varco Technosolutions, Inc. was declared as non-responsive and their financial bid was not opened.

WHEREAS, after due consideration and deliberation, the BAC is constrained, and thus, resolved to declare a failure of bidding for the Enhancement and Maintenance Support Services for Various Public Financial Management (PFM) Application Systems of the Bureau of the Treasury (RE-BID) due to the ineligibility of the bidder during the preliminary examination;

NOW THEREFORE, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

- a. declare failure of bidding for the Enhancement and Maintenance Support Services for Various Public Financial Management (PFM) Application Systems of the Bureau of the Treasury (RE-BID);
