RESOLUTION NO. 96 - 2022

**DECLARING FAILURE OF BIDDING AND RECOMMENDING THE RE-BID FOR THE
SUPPLY, INSTALLATION, AND COMMISSIONING OF VARIOUS ICT EQUIPMENT
FOR THE NATIONAL REGISTRY OF SCRIPLESS SECURITIES SYSTEM OF
THE BUREAU OF THE TREASURY / ITB-36-2022-G**

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Supply, Installation, and Commissioning of Various ICT Equipment for the National Registry of Scripless Securities System of Bureau of the Treasury with an Approved Budget for the Contract (ABC) of Twenty-Four Million Six Hundred Seventy-Five Thousand Pesos (PHP24,675,000.00), inclusive of all applicable taxes;

WHEREAS, on November 24, 2022, the Invitation to bid was posted through the Philippine Government Electronic Procurement System (PhilGEPS) and the BTr website;

WHEREAS, on December 2, 2022, during the scheduled Pre-Bidding Conference, three (3) prospective bidders, namely, 1) Integrated Computer Systems, Inc., 2) Infocentric Solutions Inc. and 3) Allcard Inc. attended but only Integrated Computer Systems, Inc., and Allcard Inc. purchased the bidding documents;

WHEREAS, on December 13, 2022, Supplemental Bid Bulletin Nos. 38-2022 was issued to modify/amend items in the Bid Documents, in response to the queries and clarifications made during the Pre-Bid Conference;

WHEREAS, on December 20, 2022, only one (1) bidder, Integrated Computer Systems, Inc., participated in the bidding;

WHEREAS, pursuant to Resolution No 63 - 2022 dated December 20, 2022, the BAC declared Integrated Computer Systems, Inc. as the Single Calculated Bidder (SCB) and was subjected to Post-Qualification;

WHEREAS, the Technical Working Group (TWG) submitted their post qualification report, which was adopted by the BAC in a regular meeting on January 20, 2023;

WHEREAS, upon careful examination, validation and verification of all statements made and the legal, technical, and financial documents submitted by Integrated Computer Systems, Inc. as non-responsive for its failure to comply with the technical specifications/requirements as specified in the Bidding Documents;

WHEREAS, a Notice of Post-Disqualification was issued to Integrated Computer Systems, Inc. on January 20, 2023, wherein no Motion for Reconsideration was filed;

WHEREAS, after due consideration and deliberation, the BAC is constrained, and thus, resolved to declare a failure of bidding for the Supply, Installation, and Commissioning of Various ICT Equipment for the National Registry of Scripless Securities System of Bureau of the Treasury due to the ineligibility of the lone bidder;

NOW THEREFORE, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

- a. declare failure of bidding for the Supply, Installation, and Commissioning of Various ICT Equipment for the National Registry of Scripless Securities System of Bureau of the Treasury;
- b. recommend the re-bid of the Supply, Installation, and Commissioning of Various ICT Equipment for the National Registry of Scripless Securities System of Bureau of the Treasury; and
- c. recommend for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE) the foregoing findings.
