CONTRACT AGREEMENT

THIS AGREEMENT made this R28th day of January 2022 between the <u>BUREAU OF THE TREASURY</u>, with office address at Ayuntamiento Building, Cabildo Street corner Andres Soriano Avenue, Intramuros, Manila 1002 (hereinafter called "the Entity") of the one part and <u>ASAHI DESIGN CENTRE, INC.</u> with office address at RM 22 Teoff Center #355 T. NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

 - iv. Supplemental or Bid Bulletins, if any
 - Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted³;

Winning bidder⁵ agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

In consideration for the sum of PHILIPPINE PESO: TWO MILLION SEVEN HUNDRED SIXTY-FIVE THOUSAND (Php2,765,000.00), INCLUSIVE OF APPLICABLE TAX or such other sums as may be ascertained, ASAHI DESIGN CENTRE, INC. agrees to perform and deliver the "Supply and Delivery of Office Chairs for the Bureau of the Treasury (BTr) Central Office" in accordance with his/her/its accepted Bid/Quotation/Proposal.
- 4. The <u>BUREAU OF THE TREASURY</u> agrees to pay the above-mentioned sum in accordance with the terms of the Bidding/Accepted Quotation/Proposal and procurement documents.
