CONTRACT AGREEMENT

THIS AGREEMENT made this 28th day of January 2022 between the **BUREAU OF THE TREASURY**, with office address at Ayuntamiento Building, Cabildo Street corner Andres Soriano Avenue, Intramuros, Manila 1002 (hereinafter called "the Entity") of the one part and **PLDT INC.** with office address at Ramon Cojuangco Building, Makati Avenue, Makati City (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids/Quotations for certain goods and ancillary services, particularly Multiprotocol Label Switching (MPLS) Virtual Private Network (VPN) Or MPLS VPN and Internet Service Subscriptions Renewal for the Bureau of the Treasury Regional Offices (BTr-RO) and has accepted a Bid/Quotation/Proposal by the Supplier for the supply of those goods and services in the sum of PHILIPPINE PESO: SEVEN MILLION (PHP7,000,000.00), INCLUSIVE OF APPLICABLE TAX (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- 2. The following documents as required by the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, *viz.*:
 - Philippine Bidding Documents (PBDs)¹;
 - Schedule of Requirements;
 - Technical Specifications;
 - iii. General and Special Conditions of Contract2; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted³;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme4 thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder⁵ agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- In consideration for the sum of <u>PHILIPPINE PESO</u>: <u>SEVEN MILLION</u> (<u>PHP7,000,000.00</u>), <u>INCLUSIVE OF APPLICABLE TAX</u> or such other sums as may be ascertained, <u>PLDT INC</u>. agrees to perform and deliver the "Multiprotocol Label Switching (MPLS) Virtual Private Network (VPN) Or MPLS VPN and Internet Service Subscriptions Renewal for the Bureau of the Treasury Regional Offices (BTr-RO)" in accordance with his/her/its accepted Bid/Quotation/Proposal.
- 4. The <u>BUREAU OF THE TREASURY</u> agrees to pay the above-mentioned sum in accordance with the terms of the Bidding/Accepted Quotation/Proposal and procurement documents.

Supplier/Contractor Quotation/Proposal, Service Level Agreement, and other documents such as abstract of quotations/proposals, evaluation of quotations/proposals, schedule of payments required in relation to the procurement shall form part of the Contract.
