#### CONTRACT AGREEMENT

#### NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

In consideration for the sum of <a href="PHILIPPINE PESO: FOURTEEN MILLION THREE HUNDRED NINETY-ONE THOUSAND FIFTY-TWO & 80/100 (PHP14,391,052.80), INCLUSIVE OF APPLICABLE TAX or such other sums as may be ascertained, COMMANDER SECURITY SERVICES, INC. agrees to perform and deliver the "Supply of Security Services for FY 2022" in accordance with his/her/its accepted Bid/Quotation/Proposal.</a>
- The <u>BUREAU OF THE TREASURY</u> agrees to pay the above-mentioned sum in accordance with the terms of the Bidding/Accepted Quotation/Proposal and procurement documents.
