CONTRACT AGREEMENT

In consideration for the sum of <u>PHILIPPINE PESO: ONE MILLION TWO HUNDRED EIGHTEEN THOUSAND (PHP1,218,000.00), INCLUSIVE OF APPLICABLE TAX</u> or such other sums as may be ascertained, <u>DCI INTERNATIONAL I.T. SOLUTIONS & SERVICES CORPORATION</u> agrees to perform and deliver the "Supply and Delivery of Various IT equipment for the Trust Fund Management Committee (TFMC) Secretariat Lot 1 Desktop" in accordance with his/her/its accepted Bid/Quotation/Proposal.
- The <u>BUREAU OF THE TREASURY</u> agrees to pay the above-mentioned sum in accordance with the terms of the Bidding/Accepted Quotation/Proposal and procurement documents.
