In consideration for the sum of <a href="PHILIPPINE PESO: ONE MILLION FOUR HUNDRED NINETY-NINE THOUSAND NINE HUNDRED NINETY-SIX PESOS AND 96/100 (Php1,499,996.96), INCLUSIVE OF APPLICABLE TAX or such other sums as may be ascertained, INFOBAHN COMMUNICATIONS, INC. agrees to perform and deliver the "Supply and Installation of One (1) Year License to Existing Network and User Activity Monitoring Solution of the Bureau of the Treasury" in accordance with his/her/its accepted Bid/Quotation/Proposal.
- 4. The <u>BUREAU OF THE TREASURY</u> agrees to pay the above-mentioned sum in accordance with the terms of the Bidding/Accepted Quotation/Proposal and procurement documents.
