CONTRACT AGREEMENT

THIS AGREEMENT made the 18th day of November 2022 between <u>BUREAU</u> <u>OF THE TREASURY</u>, with office address at Ayuntamiento Building, Cabildo Street corner Andres Soriano Avenue, Intramuros, Manila 1002 (hereinafter called "the Entity") of the one part and <u>INTEGRATED COMPUTER SYSTEMS, INC.</u> with office address at 3F Limketkai Bldg., Ortigas Ave., San Juan, Metro Manila (hereinafter called "the Supplier") of the other part;

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

In consideration for the sum of PHILIPPINE PESO: SIX MILLION FOUR HUNDRED SIXTEEN THOUSAND SEVEN HUNDRED FORTY-FOUR PESOS (PHP6,416,744.00), INCLUSIVE OF APPLICABLE TAX or such other sums as may be ascertained, INTEGRATED COMPUTER SYSTEMS, INC. agrees to perform and deliver the "Supply, Installation and Configuration of Rackmount Servers for the Fidelity Bonding System and National Government Collection and Disbursement System" in accordance with his/her/its accepted Bid/Quotation/Proposal.
- The **BUREAU OF THE TREASURY** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding/Accepted Quotation/Proposal and procurement documents.
