### CONTRACT AGREEMENT

THIS AGREEMENT made the 4<sup>th</sup> day of January 2023 between BUREAU OF THE TREASURY, with office address at Ayuntamiento Building, Cabildo Street corner Andres Soriano Avenue, Intramuros, Manila 1002 (hereinafter called "the Entity") of the one part and SECUR LINKS NETWORK AND TECHNOLOGIES, INC. with office address at No. 15 Acsie Rd. ## NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

  or such other sums as may be ascertained, <a href="SECUR LINKS NETWORK AND TECHNOLOGIES">SECUR LINKS NETWORK AND TECHNOLOGIES</a>, <a href="INCL">INC.</a>
  agrees to perform and deliver the "Supply and Installation of One (1) Year Licenses and Support to Existing Bandwidth Manager and Application Monitoring System of the Bureau of the Treasury (BTr)" in accordance with his/her/its accepted Bid/Quotation/Proposal.</a>
- 4. The <u>BUREAU OF THE TREASURY</u> agrees to pay the above-mentioned sum in accordance with the terms of the Bidding/Accepted Quotation/Proposal and procurement documents.
