- In consideration for the sum of <u>PHILIPPINE PESO</u>: <u>FIVE MILLION TWO</u> <u>HUNDRED THOUSAND ONE HUNDRED (PHP5,200,100.00)</u>, <u>INCLUSIVE OF APPLICABLE TAX</u> or such other sums as may be ascertained, <u>PUREGOLD PRICE CLUB, INC.</u> agrees to perform and deliver the "Procurement of Various Food Items for the Bureau of the Treasury (Central and NCR Office)" in accordance with his/her/its accepted Bid/Quotation/Proposal.
- 4. The <u>BUREAU OF THE TREASURY</u> agrees to pay the above-mentioned sum in accordance with the terms of the Bidding/Accepted Quotation/Proposal and procurement documents.
