CONTRACT AGREEMENT

THIS AGREEMENT made this 24th day of January 2022 between the **BUREAU OF THE TREASURY**, with office address at Ayuntamiento Building, Cabildo Street corner Andres Soriano Avenue, Intramuros, Manila 1002 (hereinafter called "the Entity") of the one part and **INFOBAHN COMMUNICATIONS, INC.** with office address at 2/F DRB (Fil-American) Bldg., 923 Aurora Blvd, Cor. La Salle St., Cubao, Quezon City (hereinafter called "the Supplier") of the other part;

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- The <u>BUREAU OF THE TREASURY</u> agrees to pay the above-mentioned sum in accordance with the terms of the Bidding/Accepted Quotation/Proposal and procurement documents.
