

| 5.1.1.2 87 units of Pole stand to hold/support device, and with UPS cage/enclosure for easier transport; design to be approved by BTr. | |
| Add item 5.1.1.2.1 | 5.1.1.2.1 Height, tilt angle, and other specific details of the biometric setup shall be defined with respect to the proper orientation of the proposed biometrics device and UPS. |
| Add item 5.1.1.2.2 | 5.1.1.2.2 Biometrics must be attached to the pole in a secure/stable, ergonomic and enterprise-grade presentation. |
| Add item 5.1.1.2.3 | 5.1.1.2.3 Material to be used for the body can be made out of Galvanized Iron, equivalent or higher quality. |

| Add item 5.1.1.2.5 | 5.1.1.2.5 The three sides of the Enclosure (Right, Left and back), must have louvers for ventilation purposes. The front side is the door and must have a lock. |
| Add item 5.1.1.2.6 | 5.1.1.2.6 Must have four (4) heavy duty swivel caster wheels with lock for easy transport. |
