# ***Glossary of Acronyms, Terms, and Abbreviations***

**ABC** – Approved Budget for the Contract.

**BAC** – Bids and Awards Committee.

**Bid** – A signed offer or proposal to undertake a contract submitted by a bidder in response to and in consonance with the requirements of the bidding documents. Also referred to as *Proposal* and *Tender*. (2016 revised IRR, Section 5[c])

**Bidder** – Refers to a contractor, manufacturer, supplier, distributor and/or consultant who submits a bid in response to the requirements of the Bidding Documents. (2016 revised IRR, Section 5[d])

**Bidding Documents** – The documents issued by the Procuring Entity as the bases for bids, furnishing all information necessary for a prospective bidder to prepare a bid for the Goods, Infrastructure Projects, and/or Consulting Services required by the Procuring Entity. (2016 revised IRR, Section 5[e])

**BIR** – Bureau of Internal Revenue.

**BSP** – Bangko Sentral ng Pilipinas.

**Consulting Services** – Refer to services for Infrastructure Projects and other types of projects or activities of the GOP requiring adequate external technical and professional expertise that are beyond the capability and/or capacity of the GOP to undertake such as, but not limited to: (i) advisory and review services; (ii) pre-investment or feasibility studies; (iii) design; (iv) construction supervision; (v) management and related services; and (vi) other technical services or special studies. (2016 revised IRR, Section 5[i])

**CDA** - Cooperative Development Authority.

**Contract** – Refers to the agreement entered into between the Procuring Entity and the Supplier or Manufacturer or Distributor or Service Provider for procurement of Goods and Services; Contractor for Procurement of Infrastructure Projects; or Consultant or Consulting Firm for Procurement of Consulting Services; as the case may be, as recorded in the Contract Form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.

**CIF** – Cost Insurance and Freight.

**CIP** – Carriage and Insurance Paid.

**CPI** – Consumer Price Index.

**DDP** – Refers to the quoted price of the Goods, which means “delivered duty paid.”

**DTI** – Department of Trade and Industry.

**EXW** – Ex works.

**FCA** – “Free Carrier” shipping point.

**FOB** – “Free on Board” shipping point.

**Foreign-funded Procurement or Foreign-Assisted Project**– Refers to procurement whose funding source is from a foreign government, foreign or international financing institution as specified in the Treaty or International or Executive Agreement. (2016 revised IRR, Section 5[b]).

**Framework Agreement** – Refers to a written agreement between a procuring entity and a supplier or service provider that identifies the terms and conditions, under which specific purchases, otherwise known as “Call-Offs,” are made for the duration of the agreement. It is in the nature of an option contract between the procuring entity and the bidder(s) granting the procuring entity the option to either place an order for any of the goods or services identified in the Framework Agreement List or not buy at all, within a minimum period of one (1) year to a maximum period of three (3) years. (GPPB Resolution No. 27-2019)

**GFI** – Government Financial Institution.

**GOCC** – Government-owned and/or –controlled corporation.

**Goods** – Refer to all items, supplies, materials and general support services, except Consulting Services and Infrastructure Projects, which may be needed in the transaction of public businesses or in the pursuit of any government undertaking, project or activity, whether in the nature of equipment, furniture, stationery, materials for construction, or personal property of any kind, including non-personal or contractual services such as the repair and maintenance of equipment and furniture, as well as trucking, hauling, janitorial, security, and related or analogous services, as well as procurement of materials and supplies provided by the Procuring Entity for such services. The term “related” or “analogous services” shall include, but is not limited to, lease or purchase of office space, media advertisements, health maintenance services, and other services essential to the operation of the Procuring Entity. (2016 revised IRR, Section 5[r])

**GOP** – Government of the Philippines.

**GPPB** – Government Procurement Policy Board.

**INCOTERMS** – International Commercial Terms.

**Infrastructure Projects** – Include the construction, improvement, rehabilitation, demolition, repair, restoration or maintenance of roads and bridges, railways, airports, seaports, communication facilities, civil works components of information technology projects, irrigation, flood control and drainage, water supply, sanitation, sewerage and solid waste management systems, shore protection, energy/power and electrification facilities, national

buildings, school buildings, hospital buildings, and other related construction projects of the government. Also referred to as *civil works or works*. (2016 revised IRR, Section 5[u])

**LGUs** – Local Government Units.

**NFCC** – Net Financial Contracting Capacity.

**NGA** – National Government Agency.

**PhilGEPS** - Philippine Government Electronic Procurement System.

**Procurement Project** – refers to a specific or identified procurement covering goods, infrastructure project or consulting services. A Procurement Project shall be described, detailed, and scheduled in the Project Procurement Management Plan prepared by the agency which shall be consolidated in the procuring entity's Annual Procurement Plan. (GPPB Circular No. 06-2019 dated 17 July 2019)

**PSA** – Philippine Statistics Authority.

**SEC** – Securities and Exchange Commission.

**SLCC** – Single Largest Completed Contract.

**Supplier** – refers to a citizen, or any corporate body or commercial company duly organized and registered under the laws where it is established, habitually established in business and engaged in the manufacture or sale of the merchandise or performance of the general services covered by his bid. (Item 3.8 of GPPB Resolution No. 13-2019, dated 23 May 2019). Supplier as used in these Bidding Documents may likewise refer to a distributor, manufacturer, contractor, or consultant.

**UN** – United Nations.

**INVITATION TO BID**

1. The **Bureau of the Treasury (BTr)**, through the **National Expenditures Program FY 2023** intends to apply the sum of **Sixteen Million Eight Hundred Eighty Two Thousand Pesos (Php16,882,000.00)** being the ABC to payments under the contract for **Supply of Security Services FY 2023 / ITB-15-2023-G (EPA)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **BTr** now invites bids for the above Procurement Project. Delivery of the Goods is required by **One (1) year upon receipt of Notice to Proceed**. Bidders should have completed, within the **last three (3) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
  - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
4. Prospective Bidders may obtain further information from the Office of the BTr Bids and Awards Committee (BAC) Secretariat and inspect the Bidding Documents at the address given below during 8:00 am to 5:00 pm.

***A pre-registration will be conducted to prospective bidders who wish to attend the scheduled bidding activities. Only those who registered will be provided an invitation/link for the scheduled Pre-Bid Conference. Please refer to the pre-registration link:***

5. A complete set of Bidding Documents may be acquired by interested Bidders on November 25, 2022 from the given address and website(s) below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Twelve Thousand Pesos (Php12,000.00)**.*

6. The **BTr-BAC** will hold a Pre-Bid Conference<sup>1</sup> on **December 5, 2022 , 4:00 pm via 2zoom** which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through online or electronic submission as indicated below, on or before **8:00 am of December 14, 2022**. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be on **December 14, 2022, 4:00 pm, via zoom**. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The **electronic** submission of bidding documents shall be made only to the official email: **e-bids@treasury.gov.ph**. Only pre-registered bidders who have received meeting invitation link and with submitted proof of payment of bidding documents (e.g. electronic payment system transaction receipt, validated bank deposit slip) will be allowed to submit their bids
11. The **BTr-BAC** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.

## ***Section II. Instructions to Bidders***

## 1. Scope of Bid

The Procuring Entity, Bureau of the Treasury wishes to receive Bids for **Supply of Security Services FY 2023 / ITB-15-2023-G (EPA)**.

The Procurement Project (referred to herein as “Project”) is composed of , one (1) lot, the details of which are described in Section VII (Technical Specifications). of being the ABC to payments under the contract for Funding Information.

2.1. The GOP through the source of funding as indicated below for the **National Expenditures Program FY 2023** in the amount of **Sixteen Million Eight Hundred Eighty Two Thousand Pesos (Php16,882,000.00)**

2.2. The source of funding is:

## 2. Bidding Requirements

The Bidding for the Project shall be governed by all the provisions of RA No. 9184 and its 2016 revised IRR, including its Generic Procurement Manuals and associated policies, rules and regulations as the primary source thereof, while the herein clauses shall serve as the secondary source thereof.

Any amendments made to the IRR and other GPPB issuances shall be applicable only to the ongoing posting, advertisement, or **IB** by the BAC through the issuance of a supplemental or bid bulletin.

The Bidder, by the act of submitting its Bid, shall be deemed to have verified and accepted the general requirements of this Project, including other factors that may affect the cost, duration and execution or implementation of the contract, project, or work and examine all instructions, forms, terms, and project requirements in the Bidding Documents.

## 3. Corrupt, Fraudulent, Collusive, and Coercive Practices

The Procuring Entity, as well as the Bidders and Suppliers, shall observe the highest standard of ethics during the procurement and execution of the contract. They or through an agent shall not engage in corrupt, fraudulent, collusive, coercive, and obstructive practices defined under Annex “I” of the 2016 revised IRR of RA No. 9184 or other integrity violations in competing for the Project.

## 4. Eligible Bidders

5.1. Only Bids of Bidders found to be legally, technically, and financially capable will be evaluated.

5.2. *[Select one, delete other/s]*

- a. Foreign ownership exceeding those allowed under the rules may participate pursuant to:
    - i. When a Treaty or International or Executive Agreement as provided in Section 4 of the RA No. 9184 and its 2016 revised IRR allow foreign bidders to participate;
    - ii. Citizens, corporations, or associations of a country, included in the list issued by the GPPB, the laws or regulations of which grant reciprocal rights or privileges to citizens, corporations, or associations of the Philippines;
    - iii. When the Goods sought to be procured are not available from local suppliers; or
    - iv. When there is a need to prevent situations that defeat competition or restrain trade.
  - b. Foreign ownership limited to those allowed under the rules may participate in this Project.
- 5.3. Pursuant to Section 23.4.1.3 of the 2016 revised IRR of RA No.9184, the Bidder shall have an SLCC that is at least one (1) contract similar to the Project the value of which, adjusted to current prices using the PSA's CPI, must be at least equivalent to:
- a. **For the procurement of Non-expendable Supplies and Services: The Bidder must have completed a single contract that is similar to this Project, equivalent to at least fifty percent (50%) of the ABC.**
- 5.4. The Bidders shall comply with the eligibility criteria under Section 23.4.1 of the 2016 IRR of RA No. 9184.

## 5. Origin of Goods

There is no restriction on the origin of goods other than those prohibited by a decision of the UN Security Council taken under Chapter VII of the Charter of the UN, subject to Domestic Preference requirements under **ITB** Clause 18.

## 6. Subcontracts

- 7.1. The Bidder may subcontract portions of the Project to the extent allowed by the Procuring Entity as stated herein, but in no case more than twenty percent (20%) of the Project.

The Procuring Entity has prescribed that:

- a. Subcontracting is not allowed.

## 7. Pre-Bid Conference

The Procuring Entity will hold a pre-bid conference for this Project on the specified date and time and either at its physical address *{[insert if applicable]}* and/or through videoconferencing/webcasting} as indicated in paragraph 6 of the **IB**.

## 8. Clarification and Amendment of Bidding Documents

Prospective bidders may request for clarification on and/or interpretation of any part of the Bidding Documents. Such requests must be in writing and received by the Procuring Entity, either at its given address or through electronic mail indicated in the **IB**, at least ten (10) calendar days before the deadline set for the submission and receipt of Bids.

## 9. Documents comprising the Bid: Eligibility and Technical Components

- 10.1. The first envelope shall contain the eligibility and technical documents of the Bid as specified in **Section VIII (Checklist of Technical and Financial Documents)**.
- 10.2. The Bidder's SLCC as indicated in **ITB** Clause 5.3 should have been completed within *[state relevant period as provided in paragraph 2 of the IB]* prior to the deadline for the submission and receipt of bids.
- 10.3. If the eligibility requirements or statements, the bids, and all other documents for submission to the BAC are in foreign language other than English, it must be accompanied by a translation in English, which shall be authenticated by the appropriate Philippine foreign service establishment, post, or the equivalent office having jurisdiction over the foreign bidder's affairs in the Philippines. Similar to the required authentication above, for Contracting Parties to the Apostille Convention, only the translated documents shall be authenticated through an apostille pursuant to GPPB Resolution No. 13-2019 dated 23 May 2019. The English translation shall govern, for purposes of interpretation of the bid.

## 10. Documents comprising the Bid: Financial Component

- 11.1. The second bid envelope shall contain the financial documents for the Bid as specified in **Section VIII (Checklist of Technical and Financial Documents)**.
- 11.2. If the Bidder claims preference as a Domestic Bidder or Domestic Entity, a certification issued by DTI shall be provided by the Bidder in accordance with Section 43.1.3 of the 2016 revised IRR of RA No. 9184.
- 11.3. Any bid exceeding the ABC indicated in paragraph 1 of the **IB** shall not be accepted.
- 11.4. For Foreign-funded Procurement, a ceiling may be applied to bid prices provided the conditions are met under Section 31.2 of the 2016 revised IRR of RA No. 9184.

- 11.5. *[Include if Framework Agreement will be used:]* Financial proposals for single or multi-year Framework Agreement shall be submitted before the deadline of submission of bids as prescribed in the **IB**. For multi-year Framework Agreement, evaluation of the financial proposal during this stage is for purposes of determining eligibility and whether or not such financial proposal is within the ABC.

## 11. Bid Prices

- 12.1. Prices indicated on the Price Schedule shall be entered separately in the following manner:

- a. For Goods offered from within the Procuring Entity's country:
  - i. The price of the Goods quoted EXW (ex-works, ex-factory, ex-warehouse, ex-showroom, or off-the-shelf, as applicable);
  - ii. The cost of all customs duties and sales and other taxes already paid or payable;
  - iii. The cost of transportation, insurance, and other costs incidental to delivery of the Goods to their final destination; and
  - iv. The price of other (incidental) services, if any, listed in e.
- b. For Goods offered from abroad:
  - i. Unless otherwise stated in the **BDS**, the price of the Goods shall be quoted delivered duty paid (DDP) with the place of destination in the Philippines as specified in the **BDS**. In quoting the price, the Bidder shall be free to use transportation through carriers registered in any eligible country. Similarly, the Bidder may obtain insurance services from any eligible source country.
  - ii. The price of other (incidental) services, if any, as listed in **Section VII (Technical Specifications)**.

- 12.2. *[Include if Framework Agreement will be used:]* For Framework Agreement, the following should also apply in addition to Clause 12.1:

- a. For a single year Framework Agreement, the prices quoted by the Bidder shall be fixed during the Bidder's performance of the contract and not subject to variation or escalation on any account. Price schedules required under Clause 12.1 shall be submitted with the bidding documents.
- b. For a multi-year Framework Agreement, the prices quoted by the Bidder during submission of eligibility documents shall be the ceiling and the price quoted during mini-competition must not exceed the initial price offer. The price quoted during call for mini-competition shall be fixed during the Bidder's performance of that Call-off and not subject to variation or

escalation on any account. Price schedules required under Clause 12.1 shall be submitted with the bidding documents.

## 12. Bid and Payment Currencies

13.1. For Goods that the Bidder will supply from outside the Philippines, the bid prices may be quoted in the local currency or tradeable currency accepted by the BSP at the discretion of the Bidder. However, for purposes of bid evaluation, Bids denominated in foreign currencies, shall be converted to Philippine currency based on the exchange rate as published in the BSP reference rate bulletin on the day of the bid opening.

13.2. Payment of the contract price shall be made in:

a. **Philippine Pesos.**

## 13. Bid Security

14.1. The Bidder shall submit a Bid Securing Declaration<sup>2</sup> or any form of Bid Security in the amount indicated in the **BDS**, which shall be not less than the percentage of the ABC in accordance with the schedule in the **BDS**.

14.2. The Bid and bid security shall be valid until **120 days (October 12, 2021)**. Any Bid not accompanied by an acceptable bid security shall be rejected by the Procuring Entity as non-responsive.

14.3. *[Include if Framework Agreement will be used:]* In the case of Framework Agreement, other than the grounds for forfeiture under the 2016 revised IRR, the bid security may also be forfeited if the successful bidder fails to sign the Framework Agreement, or fails to furnish the performance security or performance securing declaration. Without prejudice on its forfeiture, bid securities shall be returned only after the posting of performance security or performance securing declaration, as the case may be, by the winning Bidder or compliant Bidders and the signing of the Framework Agreement.

## 14. Sealing and Marking of Bids

Each Bidder shall submit one copy of the first and second components of its Bid.

The Procuring Entity may request additional hard copies and/or electronic copies of the Bid. However, failure of the Bidders to comply with the said request shall not be a ground for disqualification.

If the Procuring Entity allows the submission of bids through online submission or any other electronic means, the Bidder shall submit an electronic copy of its Bid, which must be digitally signed. **An electronic copy that cannot be opened or is corrupted shall be considered non-responsive and, thus, automatically disqualified.**

<sup>2</sup> In the case of Framework Agreement, the undertaking shall refer to entering into contract with the Procuring Entity and furnishing of the performance security or the performance securing declaration within ten (10) calendar days from receipt of Notice to Execute Framework Agreement.

## **15. Deadline for Submission of Bids**

- 16.1. The Bidders shall submit on the specified date and time and either at its physical address or through online submission as indicated in paragraph 7 of the **IB**.
- 16.2. *[Include if Framework Agreement will be used:]* For multi-year Framework Agreement, the submission of bids shall be for the initial evaluation of their technical and financial eligibility. Thereafter, those declared eligible during the said initial eligibility evaluation and entered into a Framework Agreement with the Procuring Entity shall submit anew their best financial offer at the address and on or before the date and time indicated in the Call for each mini-competition.

## **16. Opening and Preliminary Examination of Bids**

- 17.1. The BAC shall open the Bids in public at the time, on the date, and at the place specified in paragraph 9 of the **IB**. The Bidders' representatives who are present shall sign a register evidencing their attendance. In case videoconferencing, webcasting or other similar technologies will be used, attendance of participants shall likewise be recorded by the BAC Secretariat.

In case the Bids cannot be opened as scheduled due to justifiable reasons, the rescheduling requirements under Section 29 of the 2016 revised IRR of RA No. 9184 shall prevail.

- 17.2. The preliminary examination of bids shall be governed by Section 30 of the 2016 revised IRR of RA No. 9184.

## **17. Domestic Preference**

- 18.1. The Procuring Entity will grant a margin of preference for the purpose of comparison of Bids in accordance with Section 43.1.2 of the 2016 revised IRR of RA No. 9184.
- 18.2. *[Include if Framework Agreement will be used:]* For multi-year Framework Agreement, determination of margin of preference shall be conducted every call for Mini-Competition.

## **18. Detailed Evaluation and Comparison of Bids**

- 19.1. The Procuring BAC shall immediately conduct a detailed evaluation of all Bids rated "*passed*," using non-discretionary pass/fail criteria. The BAC shall consider the conditions in the evaluation of Bids under Section 32.2 of the 2016 revised IRR of RA No. 9184.

*[Include the following options if Framework Agreement will be used:]*

- a. In the case of single-year Framework Agreement, the Lowest Calculated Bid shall be determined outright after the detailed evaluation;

## ***Section IV. General Conditions of Contract***

## 1. Scope of Contract

This Contract shall include all such items, although not specifically mentioned, that can be reasonably inferred as being required for its completion as if such items were expressly mentioned herein. All the provisions of RA No. 9184 and its 2016 revised IRR, including the Generic Procurement Manual, and associated issuances, constitute the primary source for the terms and conditions of the Contract, and thus, applicable in contract implementation. Herein clauses shall serve as the secondary source for the terms and conditions of the Contract.

This is without prejudice to Sections 74.1 and 74.2 of the 2016 revised IRR of RA No. 9184 allowing the GPPB to amend the IRR, which shall be applied to all procurement activities, the advertisement, posting, or invitation of which were issued after the effectivity of the said amendment.

## 2. Advance Payment and Terms of Payment

**They shall be responsible:**

- 1.** To safeguard the Bureau of the Treasury (BTr) areas at Ayuntamiento Building, and Palacio del Gobernador Building, as well as BTr-maintained properties at Mandaluyong City, and New Manila, Quezon City from fire hazards, criminal infiltration, sabotage, bomb threats, vandalism, and other forms of physical destruction.
- 2.** To safeguard vehicles, equipment, furniture, supplies, and other materials of BTr against theft, robbery, fire, arson, and similar incidents.
- 3.** To provide security for top management officers within BTr premises.
  - a) Secure the Treasurer of the Philippines from bodily harm or any and all forms of threat to his/her safety and security.
  - b) Secure the Deputy Treasurers of the Philippines from any and all forms of threats to their safety and security.
  - c) Secure other government officials entering the BTr premises on official business.
- 4.** To safeguard BTr personnel against harm or threats when inside the Bureau premises during office hours.
- 5.** To promote and maintain peace and order within BTr premises, and in assigned areas of responsibility including, but not limited to, designated restricted and high-risk areas within BTr premises.

6. To be accountable for all equipment and materials entrusted or issued to security provider's personnel, and report immediately any damage to said equipment or materials.
7. To expedite any and all activities in support of the mission and objectives of the Administrative Service including all legal and lawful instructions handed down by the higher authority.
8. To record and document in the Security Guard's logbook all significant events occurring in his/her area of responsibility and/or report in writing any incident inimical to the integrity of the Bureau of the Treasury.
9. To maintain proper decorum, personal discipline, proper grooming in uniform, while on duty, and refrain from reading newspapers, drinking any alcoholic beverage, or taking prohibited drugs, or any other wrongdoing that will distract him/her from performing his/her official function.
10. To comply with Orders, Circulars, and other policies of the BTr, including lawful orders by the Chief, Facilities Maintenance Division, and Administrative Service.
11. To strictly comply with R.A. 5487 as amended by P.D. 1919, otherwise known as the Private Security Agency Law, and its implementing rules and regulations.
12. To assist in the renewal of BTR firearms licenses, License to Own and Possess Firearm (LTOPF) and Permit to Carry (PTC).

**B. At least four (4) of the Thirty-Five (35) security guards (two for the day shift, and two for the night shift) shall operate and monitor the Closed-Circuit Television (CCTV), twelve (12) hours a day, seven (7) days a week, alternately and perform other functions assigned by the Chief of Facilities Maintenance Division.**

The assigned personnel must have a minimum experience of at least one (1) year in operating a CCTV system. In addition to the responsibilities as stated in paragraph A, the CCTV Operator shall be responsible:

- To monitor events and actions through the CCTV in an efficient manner and maintain an efficient data storage, archiving and file management system.
- To report equipment system failure to the Chief Facilities Maintenance Division, Administrative Service, and recommend possible solutions.
- To report all suspicious events in written format.
- To restrict access to all unauthorized personnel to the control room to maintain high security and confidentiality of the CCTV operations.

## II. PROJECT DURATION

## V. STANDARD REQUIREMENTS AND BIDDER'S COMPLIANCE

### 1. TRACK RECORD

1.1. The Contractor must have completed within the last three years a single largest contract similar to the project to be bid with an amount equivalent to at least fifty percent (50%) of the Approved Budget for the Contract

## VI. OTHER RESPONSIBILITIES OF THE SUPPLIER/CONTRACTOR

- a. The Contractor shall maintain physically fit Security Guards assigned to and accepted by the BTr, to render security services for the duration of the contract, unless otherwise advised by BTr. The guards to be assigned to BTr shall undergo a physical fitness test to be done by the contractor in the presence of BTr representative.
- b. The discipline and administration of the security guards shall be the responsibility of the security agency.
- c. The Contractor's personnel rendering unsatisfactory performance, questionable behavior, or violating BTr house rules and regulations shall be immediately replaced upon receipt of the written memorandum from BTr. On the other hand, the Contractor shall not arbitrarily replace the security guard/s without prior approval from BTr.
- d. The Contractor shall provide security personnel with the following minimum requirements:
  - 18 units of licensed 9mm firearms
  - 5 units of licensed shotgun
  - 1 magazine ammunition for each firearm
  - 24 sets of licensed two-way radio communication system
  - 24 extra battery packs

- 10 emergency lights, flashlight, with batteries,
  - 4 handheld metal detectors
  - 3 units of the vehicle under chassis inspection mirror
  - 5 units of traffic wand
  - 6 set reflectorized traffic vest
  - 3 units of Non-Contact Infrared Temperature Scanner with stand
  - 3 Automatic Alcohol Spray / Dispenser.
- e. The security guards deployed by the contractor shall not be considered employees of BTr and accordingly, BTr cannot be held responsible for any claims by guards or third persons - for compensation for personal injury, damage, or death, where such injury or damage was occasioned by the performance of their tasks.
  - f. The Contractor's security guards shall not be allowed to stay in the building premises when not on duty unless unforeseen conditions prevail.
  - g. The Contractor shall require its security guards to render services in accordance with the contract and to report at least thirty (30) minutes earlier prior to reporting to their respective posts.
  - h. The Contractor shall provide at least six (6) security relievers ready in case regular posted guards are absent.
  - i. The Contractor shall require its security guards to render services exceeding the scheduled working hours, in the exigency of the service, and as the need arises. Absent security personnel shall immediately be replaced with substitute personnel.
  - j. The Contractor shall assume full responsibility for any liabilities, causes of action, or claims which may be filed by any of the security guards under Labor Laws, Employees Compensation Laws, or other special laws, rules, and regulations mandated by the Department of Labor and Employment which are now in effect and by virtue hereof, the Contractor shall render BTr, its officers and employees free and harmless from any of such liabilities, causes of action or claims.
  - k. The Contractor shall be responsible for loss, damage, or injury that may be suffered by BTr, its officials, employees, and third parties – provided the incident is made known in writing to the Contractor within twenty-four (24) hours of occurrence or discovery thereof when such loss or damage is due to the fault or negligence of the deployed security guards. It is expressly understood that the Contractor shall not be liable for loss or damage due to unexpected events or force majeure except when the Contractor or its security guards are observed to be at fault or negligent. The Contractor shall guarantee the payment of any loss or damage to BTr, its personnel, or third parties after proper investigation has been conducted and it is established that loss or damage is the result of the act, omission and negligence and/or reckless imprudence of any member of the contractor's deployed personnel.
  - l. The Contractor shall submit to BTr - proof of remittance of statutory deductions which includes but not limited to SSS, Pag-IBIG, PhilHealth, etc., within fifteen (15) days after the end of each month.

- m. The Contractor shall comply with Philippine labor standards, especially in the payment of wages and benefits for its security guards.
- n. The Contractor shall provide security augmentation during important occasions or milestone events as requested by BTr. Provision of a K-9 unit or additional high-powered weapon may also be requested by BTr.
- o. The Contractor shall likewise submit the following:
  - 1. Certification of Good Standing from the Philippine National Police Security Agency and Guards Supervision Division (PNP-SAGSD) and the Philippine Association of Detective and Protective Agency Operators (PADPAO).
  - 2. Certified copy of License to Operate as Security Agency from Philippine National Police.
  - 3. Surety Bond (Third Party Liability Insurance) for all security guards.
- p. The contractor shall provide additional CCTV units:
  - 10 units for Ayuntamiento Building - blind spot areas
  - 4 units for BTr Property at Mandaluyong and
  - 2 units for BTr property at New Manila, QC
- q. The contractor shall provide a remote CCTV mobile/monitoring device to the assigned DC/OIC with unlimited call and text to all networks (with at least 512GB memory and a 12.9" screen/display).
- r. The contractor shall provide four (4) units of modular prefabricated guard house/booth to be installed at the two corners of the Ayuntamiento Building, BTr property at Mandaluyong City, and New Manila, Quezon City.
- s. The contractor shall assist BTr in the renewal of BTr firearms licenses, LTOPF and permit to carry firearms.
- t. The contractor shall provide one (1) unit four-wheeled emergency/patrol vehicle, fully air-conditioned, well-maintained, in good running condition and not older than seven (7) years.

## **VII. RESERVATION CLAUSE**

BTr reserves the right to reject documents that do not comply with requirements; waive any formalities of documents, or consider any submission of documents as substantial compliance; reject any and all bids; declare a failure of bidding, annul the bidding process, or not award the contract - without thereby incurring any liability to the affected bidder or bidders, or if the funds / allotment for the program / project / activity has been withheld or reduced through no fault of BTr.

The BTr assumes no responsibility whatsoever to compensate or indemnify bidders for any expenses incurred in the preparation of their bids.
