## ***Glossary of Acronyms, Terms, and Abbreviations***

**ABC** – Approved Budget for the Contract.

**BAC** – Bids and Awards Committee.

**Bid** – A signed offer or proposal to undertake a contract submitted by a bidder in response to and in consonance with the requirements of the bidding documents. Also referred to as *Proposal* and *Tender*. (2016 revised IRR, Section 5[c])

**Bidder** – Refers to a contractor, manufacturer, supplier, distributor and/or consultant who submits a bid in response to the requirements of the Bidding Documents. (2016 revised IRR, Section 5[d])

**Bidding Documents** – The documents issued by the Procuring Entity as the bases for bids, furnishing all information necessary for a prospective bidder to prepare a bid for the Goods, Infrastructure Projects, and/or Consulting Services required by the Procuring Entity. (2016 revised IRR, Section 5[e])

**BIR** – Bureau of Internal Revenue.

**BSP** – Bangko Sentral ng Pilipinas.

**Consulting Services** – Refer to services for Infrastructure Projects and other types of projects or activities of the GOP requiring adequate external technical and professional expertise that are beyond the capability and/or capacity of the GOP to undertake such as, but not limited to: (i) advisory and review services; (ii) pre-investment or feasibility studies; (iii) design; (iv) construction supervision; (v) management and related services; and (vi) other technical services or special studies. (2016 revised IRR, Section 5[i])

**CDA** - Cooperative Development Authority.

**Contract** – Refers to the agreement entered into between the Procuring Entity and the Supplier or Manufacturer or Distributor or Service Provider for procurement of Goods and Services; Contractor for Procurement of Infrastructure Projects; or Consultant or Consulting Firm for Procurement of Consulting Services; as the case may be, as recorded in the Contract Form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.

**CIF** – Cost Insurance and Freight.

**CIP** – Carriage and Insurance Paid.

**CPI** – Consumer Price Index.

**DDP** – Refers to the quoted price of the Goods, which means “delivered duty paid.”

**DTI** – Department of Trade and Industry.

**EXW** – Ex works.

**FCA** – “Free Carrier” shipping point.

**FOB** – “Free on Board” shipping point.

**Foreign-funded Procurement or Foreign-Assisted Project**– Refers to procurement whose funding source is from a foreign government, foreign or international financing institution as specified in the Treaty or International or Executive Agreement. (2016 revised IRR, Section 5[b]).

**Framework Agreement** – Refers to a written agreement between a procuring entity and a supplier or service provider that identifies the terms and conditions, under which specific purchases, otherwise known as “Call-Offs,” are made for the duration of the agreement. It is in the nature of an option contract between the procuring entity and the bidder(s) granting the procuring entity the option to either place an order for any of the goods or services identified in the Framework Agreement List or not buy at all, within a minimum period of one (1) year to a maximum period of three (3) years. (GPPB Resolution No. 27-2019)

**GFI** – Government Financial Institution.

**GOCC** – Government-owned and/or –controlled corporation.

**Goods** – Refer to all items, supplies, materials and general support services, except Consulting Services and Infrastructure Projects, which may be needed in the transaction of public businesses or in the pursuit of any government undertaking, project or activity, whether in the nature of equipment, furniture, stationery, materials for construction, or personal property of any kind, including non-personal or contractual services such as the repair and maintenance of equipment and furniture, as well as trucking, hauling, janitorial, security, and related or analogous services, as well as procurement of materials and supplies provided by the Procuring Entity for such services. The term “related” or “analogous services” shall include, but is not limited to, lease or purchase of office space, media advertisements, health maintenance services, and other services essential to the operation of the Procuring Entity. (2016 revised IRR, Section 5[r])

**GOP** – Government of the Philippines.

**GPPB** – Government Procurement Policy Board.

**INCOTERMS** – International Commercial Terms.

**Infrastructure Projects** – Include the construction, improvement, rehabilitation, demolition, repair, restoration or maintenance of roads and bridges, railways, airports, seaports, communication facilities, civil works components of information technology projects, irrigation, flood control and drainage, water supply, sanitation, sewerage and solid waste

management systems, shore protection, energy/power and electrification facilities, national buildings, school buildings, hospital buildings, and other related construction projects of the government. Also referred to as *civil works or works*. (2016 revised IRR, Section 5[u])

**LGUs** – Local Government Units.

**NFCC** – Net Financial Contracting Capacity.

**NGA** – National Government Agency.

**PhilGEPS** - Philippine Government Electronic Procurement System.

**Procurement Project** – refers to a specific or identified procurement covering goods, infrastructure project or consulting services. A Procurement Project shall be described, detailed, and scheduled in the Project Procurement Management Plan prepared by the agency which shall be consolidated in the procuring entity's Annual Procurement Plan. (GPPB Circular No. 06-2019 dated 17 July 2019)

**PSA** – Philippine Statistics Authority.

**SEC** – Securities and Exchange Commission.

**SLCC** – Single Largest Completed Contract.

**Supplier** – refers to a citizen, or any corporate body or commercial company duly organized and registered under the laws where it is established, habitually established in business and engaged in the manufacture or sale of the merchandise or performance of the general services covered by his bid. (Item 3.8 of GPPB Resolution No. 13-2019, dated 23 May 2019). Supplier as used in these Bidding Documents may likewise refer to a distributor, manufacturer, contractor, or consultant.

**INVITATION TO BID**

1. The **Bureau of the Treasury (BTr)**, through the **Multi-Year Contractual Authority (MYCA)**, with **Reference Number MYCA-BMB-A-2023-0000013** issued on **February 13, 2023**, intends to apply the sum of **One Hundred Two Million Three Hundred Eighty Eight Thousand Four Hundred and Ninety Seven Pesos (Php102,388,497.00)** being the ABC to payments under the contract for **Multi-Year Maintenance and Support Services for NRoSS System / ITB-17-2023-G**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **BTr** now invites bids for the above Procurement Project. Delivery of the Goods is required by **One (1) Year upon receipt of Notice to Proceed renewable yearly up to three (3) years, subject to the terms and conditions of the multi-year contract**. Bidders should have completed, within **the five (5) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
  - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
4. Prospective Bidders may obtain further information from the Office of the BTr Bids and Awards Committee (BAC) Secretariat and inspect the Bidding Documents at the address given below during 8:00 am to 5:00 pm.

***A pre-registration will be conducted to prospective bidders who wish to attend the scheduled bidding activities. Only those who registered will be provided an invitation/link for the scheduled Pre-Bid Conference. Please refer to the pre-registration link:***

5. 6. The **BTr-BAC** will hold a Pre-Bid Conference<sup>1</sup> on **March 30, 2023, 9:30 am via zoom** which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through online or electronic submission as indicated below, on or before **8:00 am of April 12, 2023**. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be on **April 12, 2023, 9:30 am, via zoom**. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The *electronic* submission of bidding documents shall be made only to the official email: **e-bids@treasury.gov.ph**. Only pre-registered bidders who have received meeting invitation link and with submitted proof of payment of bidding documents (e.g. electronic payment system transaction receipt, validated bank deposit slip) will be allowed to submit their bids
11. The **BTr-BAC** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.

## ***Section II. Instructions to Bidders***

## 1. Scope of Bid

The Procuring Entity, Bureau of the Treasury wishes to receive Bids for the **Maintenance and Support Services for NRoSS System / ITB-17-2023-G.**

The Procurement Project (referred to herein as “Project”) is composed of , one (1) lot, the details of which are described in Section VII (Technical Specifications). of being the ABC to payments under the contract for Funding Information.

2.1.The GOP through the source of funding as indicated below for the through the Multi-Year Contractual Authority (MYCA), with Reference Number MYCA-BMB-A-2023-0000013 issued on February 13, 2023, intends to apply the sum of **One Hundred Two Million Three Hundred Eighty Eight Thousand Four Hundred and Ninety Seven Pesos (Php102,388,497.00)** being the ABC to payments under the contract for Multi-Year Maintenance and Support Services for NRoSS System / ITB-17-2023-G.

2.2. The source of funding is:

**MYCA-BMB-A-2023-0000013 issued on February 13, 2023.**

## 2. Bidding Requirements

The Bidding for the Project shall be governed by all the provisions of RA No. 9184 and its 2016 revised IRR, including its Generic Procurement Manuals and associated policies, rules and regulations as the primary source thereof, while the herein clauses shall serve as the secondary source thereof.

Any amendments made to the IRR and other GPPB issuances shall be applicable only to the ongoing posting, advertisement, or **IB** by the BAC through the issuance of a supplemental or bid bulletin.

The Bidder, by the act of submitting its Bid, shall be deemed to have verified and accepted the general requirements of this Project, including other factors that may affect the cost, duration and execution or implementation of the contract, project, or work and examine all instructions, forms, terms, and project requirements in the Bidding Documents.

## 3. Corrupt, Fraudulent, Collusive, and Coercive Practices

The Procuring Entity, as well as the Bidders and Suppliers, shall observe the highest standard of ethics during the procurement and execution of the contract. They or through an agent shall not engage in corrupt, fraudulent, collusive, coercive, and obstructive practices defined under Annex “I” of the 2016 revised IRR of RA No. 9184 or other integrity violations in competing for the Project.

## 4. Eligible Bidders

- 5.1. Only Bids of Bidders found to be legally, technically, and financially capable will be evaluated.
- 5.2. *[Select one, delete other/s]*
- a. Foreign ownership exceeding those allowed under the rules may participate pursuant to:
    - i. When a Treaty or International or Executive Agreement as provided in Section 4 of the RA No. 9184 and its 2016 revised IRR allow foreign bidders to participate;
    - ii. Citizens, corporations, or associations of a country, included in the list issued by the GPPB, the laws or regulations of which grant reciprocal rights or privileges to citizens, corporations, or associations of the Philippines;
    - iii. When the Goods sought to be procured are not available from local suppliers; or
    - iv. When there is a need to prevent situations that defeat competition or restrain trade.
  - b. Foreign ownership limited to those allowed under the rules may participate in this Project.
- 5.3. Pursuant to Section 23.4.1.3 of the 2016 revised IRR of RA No.9184, the Bidder shall have an SLCC that is at least one (1) contract similar to the Project the value of which, adjusted to current prices using the PSA's CPI, must be at least equivalent to:
- a. **For the procurement of Non-expendable Supplies and Services: The Bidder must have completed a single contract that is similar to this Project, equivalent to at least fifty percent (50%) of the ABC.**
- 5.4. The Bidders shall comply with the eligibility criteria under Section 23.4.1 of the 2016 IRR of RA No. 9184.

## 5. Origin of Goods

There is no restriction on the origin of goods other than those prohibited by a decision of the UN Security Council taken under Chapter VII of the Charter of the UN, subject to Domestic Preference requirements under **ITB** Clause 18.

## 6. Subcontracts

- 7.1. The Bidder may subcontract portions of the Project to the extent allowed by the Procuring Entity as stated herein, but in no case more than twenty percent (20%) of the Project.

The Procuring Entity has prescribed that:

- a. Subcontracting is not allowed.

## **7. Pre-Bid Conference**

The Procuring Entity will hold a pre-bid conference for this Project on the specified date and time and either at its physical address *{[insert if applicable]}* and/or through videoconferencing/webcasting} as indicated in paragraph 6 of the **IB**.

## **8. Clarification and Amendment of Bidding Documents**

Prospective bidders may request for clarification on and/or interpretation of any part of the Bidding Documents. Such requests must be in writing and received by the Procuring Entity, either at its given address or through electronic mail indicated in the **IB**, at least ten (10) calendar days before the deadline set for the submission and receipt of Bids.

## **9. Documents comprising the Bid: Eligibility and Technical Components**

- 10.1. The first envelope shall contain the eligibility and technical documents of the Bid as specified in **Section VIII (Checklist of Technical and Financial Documents)**.
- 10.2. The Bidder's SLCC as indicated in **ITB** Clause 5.3 should have been completed within *[state relevant period as provided in paragraph 2 of the IB]* prior to the deadline for the submission and receipt of bids.
- 10.3. If the eligibility requirements or statements, the bids, and all other documents for submission to the BAC are in foreign language other than English, it must be accompanied by a translation in English, which shall be authenticated by the appropriate Philippine foreign service establishment, post, or the equivalent office having jurisdiction over the foreign bidder's affairs in the Philippines. Similar to the required authentication above, for Contracting Parties to the Apostille Convention, only the translated documents shall be authenticated through an apostille pursuant to GPPB Resolution No. 13-2019 dated 23 May 2019. The English translation shall govern, for purposes of interpretation of the bid.

## **10. Documents comprising the Bid: Financial Component**

- 11.1. The second bid envelope shall contain the financial documents for the Bid as specified in **Section VIII (Checklist of Technical and Financial Documents)**.
- 11.2. If the Bidder claims preference as a Domestic Bidder or Domestic Entity, a certification issued by DTI shall be provided by the Bidder in accordance with Section 43.1.3 of the 2016 revised IRR of RA No. 9184.
- 11.3. Any bid exceeding the ABC indicated in paragraph 1 of the **IB** shall not be accepted.

- 11.4. For Foreign-funded Procurement, a ceiling may be applied to bid prices provided the conditions are met under Section 31.2 of the 2016 revised IRR of RA No. 9184.
- 11.5. *[Include if Framework Agreement will be used:]* Financial proposals for single or multi-year Framework Agreement shall be submitted before the deadline of submission of bids as prescribed in the **IB**. For multi-year Framework Agreement, evaluation of the financial proposal during this stage is for purposes of determining eligibility and whether or not such financial proposal is within the ABC.

## 11. Bid Prices

- 12.1. Prices indicated on the Price Schedule shall be entered separately in the following manner:
- a. For Goods offered from within the Procuring Entity's country:
    - i. The price of the Goods quoted EXW (ex-works, ex-factory, ex-warehouse, ex-showroom, or off-the-shelf, as applicable);
    - ii. The cost of all customs duties and sales and other taxes already paid or payable;
    - iii. The cost of transportation, insurance, and other costs incidental to delivery of the Goods to their final destination; and
    - iv. The price of other (incidental) services, if any, listed in e.
  - b. For Goods offered from abroad:
    - i. Unless otherwise stated in the **BDS**, the price of the Goods shall be quoted delivered duty paid (DDP) with the place of destination in the Philippines as specified in the **BDS**. In quoting the price, the Bidder shall be free to use transportation through carriers registered in any eligible country. Similarly, the Bidder may obtain insurance services from any eligible source country.
    - ii. The price of other (incidental) services, if any, as listed in **Section VII (Technical Specifications)**.
- 12.2. *[Include if Framework Agreement will be used:]* For Framework Agreement, the following should also apply in addition to Clause 12.1:
- a. For a single year Framework Agreement, the prices quoted by the Bidder shall be fixed during the Bidder's performance of the contract and not subject to variation or escalation on any account. Price schedules required under Clause 12.1 shall be submitted with the bidding documents.
  - b. For a multi-year Framework Agreement, the prices quoted by the Bidder during submission of eligibility documents shall be the ceiling and the price

quoted during mini-competition must not exceed the initial price offer. The price quoted during call for mini-competition shall be fixed during the Bidder's performance of that Call-off and not subject to variation or escalation on any account. Price schedules required under Clause 12.1 shall be submitted with the bidding documents.

## 12. Bid and Payment Currencies

13.1. For Goods that the Bidder will supply from outside the Philippines, the bid prices may be quoted in the local currency or tradeable currency accepted by the BSP at the discretion of the Bidder. However, for purposes of bid evaluation, Bids denominated in foreign currencies, shall be converted to Philippine currency based on the exchange rate as published in the BSP reference rate bulletin on the day of the bid opening.

13.2. Payment of the contract price shall be made in:

a. **Philippine Pesos.**

## 13. Bid Security

14.1. The Bidder shall submit a Bid Securing Declaration<sup>2</sup> or any form of Bid Security in the amount indicated in the **BDS**, which shall be not less than the percentage of the ABC in accordance with the schedule in the **BDS**.

14.2. The Bid and bid security shall be valid until **120 days (October 12, 2021)**. Any Bid not accompanied by an acceptable bid security shall be rejected by the Procuring Entity as non-responsive.

14.3. *[Include if Framework Agreement will be used:]* In the case of Framework Agreement, other than the grounds for forfeiture under the 2016 revised IRR, the bid security may also be forfeited if the successful bidder fails to sign the Framework Agreement, or fails to furnish the performance security or performance securing declaration. Without prejudice on its forfeiture, bid securities shall be returned only after the posting of performance security or performance securing declaration, as the case may be, by the winning Bidder or compliant Bidders and the signing of the Framework Agreement.

## 14. Sealing and Marking of Bids

Each Bidder shall submit one copy of the first and second components of its Bid.

The Procuring Entity may request additional hard copies and/or electronic copies of the Bid. However, failure of the Bidders to comply with the said request shall not be a ground for disqualification.

<sup>2</sup> In the case of Framework Agreement, the undertaking shall refer to entering into contract with the Procuring Entity and furnishing of the performance security or the performance securing declaration within ten (10) calendar days from receipt of Notice to Execute Framework Agreement.

If the Procuring Entity allows the submission of bids through online submission or any other electronic means, the Bidder shall submit an electronic copy of its Bid, which must be digitally signed. **An electronic copy that cannot be opened or is corrupted shall be considered non-responsive and, thus, automatically disqualified.**

## **15. Deadline for Submission of Bids**

- 16.1. The Bidders shall submit on the specified date and time and either at its physical address or through online submission as indicated in paragraph 7 of the **IB**.
- 16.2. *[Include if Framework Agreement will be used:]* For multi-year Framework Agreement, the submission of bids shall be for the initial evaluation of their technical and financial eligibility. Thereafter, those declared eligible during the said initial eligibility evaluation and entered into a Framework Agreement with the Procuring Entity shall submit anew their best financial offer at the address and on or before the date and time indicated in the Call for each mini-competition.

## **16. Opening and Preliminary Examination of Bids**

- 17.1. The BAC shall open the Bids in public at the time, on the date, and at the place specified in paragraph 9 of the **IB**. The Bidders' representatives who are present shall sign a register evidencing their attendance. In case videoconferencing, webcasting or other similar technologies will be used, attendance of participants shall likewise be recorded by the BAC Secretariat.

In case the Bids cannot be opened as scheduled due to justifiable reasons, the rescheduling requirements under Section 29 of the 2016 revised IRR of RA No. 9184 shall prevail.

- 17.2. The preliminary examination of bids shall be governed by Section 30 of the 2016 revised IRR of RA No. 9184.

## **17. Domestic Preference**

- 18.1. The Procuring Entity will grant a margin of preference for the purpose of comparison of Bids in accordance with Section 43.1.2 of the 2016 revised IRR of RA No. 9184.
- 18.2. *[Include if Framework Agreement will be used:]* For multi-year Framework Agreement, determination of margin of preference shall be conducted every call for Mini-Competition.

## **18. Detailed Evaluation and Comparison of Bids**

- 19.1. The Procuring BAC shall immediately conduct a detailed evaluation of all Bids rated "*passed*," using non-discretionary pass/fail criteria. The BAC shall consider the conditions in the evaluation of Bids under Section 32.2 of the 2016 revised IRR of RA No. 9184.

- 19.5. Except for bidders submitting a committed Line of Credit from a Universal or Commercial Bank in lieu of its NFCC computation, all Bids must include the NFCC computation pursuant to Section 23.4.1.4 of the 2016 revised IRR of RA No. 9184, which must be sufficient for the total of the ABCs for all the lots or items participated in by the prospective Bidder. ## ***Section IV. General Conditions of Contract***

## 1. Scope of Contract

This Contract shall include all such items, although not specifically mentioned, that can be reasonably inferred as being required for its completion as if such items were expressly mentioned herein. All the provisions of RA No. 9184 and its 2016 revised IRR, including the Generic Procurement Manual, and associated issuances, constitute the primary source for the terms and conditions of the Contract, and thus, applicable in contract implementation. Herein clauses shall serve as the secondary source for the terms and conditions of the Contract.

This is without prejudice to Sections 74.1 and 74.2 of the 2016 revised IRR of RA No. 9184 allowing the GPPB to amend the IRR, which shall be applied to all procurement activities, the advertisement, posting, or invitation of which were issued after the effectivity of the said amendment.

Additional requirements for the completion of this Contract shall be provided in the **Special Conditions of Contract (SCC)**.

## 2. Advance Payment and Terms of Payment

- A. Advance payment of the contract amount is provided under Annex “D” of the revised 2016 IRR of RA No. 9184.
- B. The Procuring Entity is allowed to determine the terms of payment on the partial or staggered delivery of the Goods procured, provided such partial payment shall correspond to the value of the goods delivered and accepted in accordance with prevailing accounting and auditing rules and regulations. ## TECHNICAL SPECIFICATIONS

### 1. PROJECT TITLE

Multi – Year Maintenance and Support Services for the NRoSS System.

### 2. BACKGROUND

The Bureau of the Treasury (BTr) operates the National Registry of Scripless Securities (NRoSS) system which serves as the official registry of the Government Securities (GS) and Bangko Sentral ng Pilipinas (BSP) securities issued in the local debt market. In addition, the NRoSS system also facilitates the auction process of the GS, and facilitates the secondary market settlement, coupon and redemption for all the securities.

As an infrastructure, the NRoSS plays a critical role in the Philippine financial market system, hence, the uninterrupted operation of the system is of a primary importance and must be ensured. In this regard, the Bureau requires maintenance and support from a CONTRACTOR.

### 3. APPROVED BUDGET OF THE CONTRACT (ABC)

The total project cost for three (3) years inclusive of applicable 12% VAT, is computed in the amount of PHP102,388,497.00 broken down as follows:

### 4. CONTRACT DURATION

The winning contractor shall provide a one (1) - year Maintenance and Support Services to the BTr for the entire NRoSS System (i.e., hardware and software) at the primary (PR) and alternate (DR) processing sites, renewable yearly up to three (3) years and shall be guided by the following:

- a. The liability of the agency for a given year shall only be limited to the available appropriations for the purpose for a specific year;
- b. Obligations to be incurred by the agency in any given calendar year shall in no case exceed the allotment released for the purpose;
- c. Annual review should be conducted by the agency concerned as part of the process/multi-year contract (MYC) to enable to negotiate for a lower price for the service in the event that the actual cost for the good or service covered by the contract become lower as per prevailing market analysis; and
- d. Procurement covering MYC shall be subject to guidelines issued by the Government Procurement Policy Board and/or DBM.

E. Creation of a work breakdown schedule for related maintenance and support activities including resources needed to complete each task, and must be subject to acceptance by the BTr

F. Provision of a Coordination Manual that defines the procedures necessary to provide the maintenance services and support.

G. Provide second level of support in establishing stable connections both for new and existing participants.

H. Must provide a Method of Procedure (MOP) prior to any changes to NRoSS system or related components.

I. Must provide As-Built documentation of the NRoSS infrastructure.

J. Must provide training to ten (10) BTr staffs on the administration, troubleshooting and proper use of NRoSS System

K. Quarterly submission of software and hardware maintenance and support report.

## **6. SERVICE LEVEL AGREEMENT**

- A. System hardware and software uptime expectation of BTr is 99.95% (where downtime is the total unavailability of system in hours in a 24x7 uptime) annually for three (3) years.
- B. Must provide at least one (1) support engineer with onsite presence during banking days in Manila, Philippines.
- C. Provision and enacting of procedures for the management of Maintenance Services guaranteeing problem classification and resolution within specified time-frames.
- D. Maintenance and Support Services availability is 7:00 a.m. – 7:00 p.m. of the working week (the time is specified in Local time in the Philippines), or at a time beyond aforementioned schedule when the problem is considered to be a blocking issue.
- E. The winning bidder must provide BTr SAD/End-User a regular update until Incident Closure.
- F. A Service Report must be provided for every support activity and should be acknowledged and signed by the attending SAD representative.
- G. Failure to resolve Incident within the prescribed uptime would mean infraction on the winning bidder and will be subject to penalties.
- H. Implement backup measure(s) during problem resolution.
- I. The winning bidder must conduct testing, quality assurance and client acceptance for every service accomplished.

## **7. REPORTING**

- A. The winning bidder must provide documentations as required on any services done to the system and shall be acknowledged and verified by the BTr-SAD.
- B. The winning bidder need to submit a detailed resolution report for every service requested within two (2) calendar days. The report should contain, but not limited to, the following information:
  - Reported downtime and uptime
  - Root cause of problem
  - Details of actions, repairs, troubleshooting and remediation done
  - Recommendations/Action Plan
  - Technical and supervising personnel involved in the problem resolution
- C. The winning bidder to provide a weekly accomplishment report for the Onsite Technical Support.

## 8. CONTRACTORS REQUIREMENT AND QUALIFICATION

- B. The bidder must have completed, within the last five (5) years from the date of submission and receipt of bids, a single contract that is similar to this project, equivalent to at least 50% of the ABC. For this purpose, similar contracts shall refer to contracts involving Maintenance Support and Services of a Government owned CSD application.
- C. Company existence of at least ten (10) years and successfully implemented CSD and Auction systems, preferably with a Sovereign Treasury or Central Bank.
- D. The bidder shall submit a statement on the technical competence of its key staff, which shall include:
  - (a) One (1) Project Manager, with relevant experience in managing deployment of financial applications
  - (b) One (1) Onsite Technical Support Engineer
  - (c) One (1) Network Administrator
  - (d) One (1) System Administrator
  - (e) One (1) Database Administrator
  - (f) Five (5) CSD Software Engineers

For clarity:

- i. Staff for items **a,b,c d & e** must have minimum of five (5) years of relevant experience to the task required and not necessarily with a CSD or Auction System.
  - ii. Staff for item **f** must have a minimum of five (5) years of relevant experience with a CSD or Auction System, including:
    - a. Trainings relevant to CSD and Auction
    - b. Projects handled and nature of involvement concerning CSD and Auction, preferably with a sovereign Treasury or Central Bank
  - iii. All staffs must have curricula vitae, including information on the following:
    - Primary and Secondary areas of expertise
    - Educational attainment
- E. Bidders are required to submit documents indicating the following.
- The structure of their proposed maintenance and support team.
  - The roles and responsibilities of each team member.



- Estimated budget for activities / services.
- Up to date certifications of engineer and/or administrator related to each of the assigned roles and services to be performed.

F. In case the winning bidder needs to change the key personnel, the competency level of the replacement personnel must be the same when bidder is declared eligible to bid, and subject to acceptance by the BTr.

## 9. MODE OF PAYMENT

Payments shall be processed quarterly. Processing of payment shall comply with government procedures and will be initiated upon certification by the BTr of complete and satisfactory delivery of the maintenance services. Vendor shall issue a billing statement supported by the quarterly maintenance report.

## 10. CONFIDENTIALITY

- A. The CONTRACTOR shall be required to sign a **Non-Disclosure Agreement**.
- B. The BTr system, its components, parts and all products, product samples and specifications, data, ideas, technology, and technical and non-technical materials, all or any of which may be derived from any of the foregoing (all of which, individually and collectively, referred to as "Proprietary Information") are confidential and proprietary to the Bureau of the Treasury.
- C. The CONTRACTOR agrees to hold the Proprietary Information in strict confidence. CONTRACTOR furthermore agrees not to reproduce, transcribe, or disclose the Proprietary Information to third parties without prior written approval of the Bureau of the Treasury.
- D. To ensure the confidentiality of all information that will come to the knowledge of the CONTRACTOR and its employees assigned to BTr, the CONTRACTOR and its employees assigned therein, shall uphold strict confidentiality of any information that has concern to the BTr, including but not be limited to IT infrastructure design/configuration and work flow/process.

## 11. NON-GRAFT CLAUSE

The winning bidder warrants that it has not given nor promised to give any money or gift to any officer or employee of the BTr, or any member of the Bids and Awards Committee (BAC), BAC Secretariat or TWG, to secure this contract.

## **12. LIQUIDATED DAMAGES**

In case of failure by vendor to perform the subject services within the period agreed upon in the agreement, BTr shall without prejudice to its other remedies under the agreement and applicable laws, deduct from the contract price, as liquidated damages, that amount of at least equal to 1/10 of 1% (0.10%) of the cost of the unperformed service for every day of delay. Quoted below is the relevant section in the IRR of RA 9184 which provides for the allowable amount of liquidated damages that may be imposed by the government in case of breach in the contracted services as agreed upon with the Contractor:

Sec 68. Liquidated Damages (Rule XXII - Civil Liability) under the Procurement Act All contracts executed in accordance with the Act and this IRR shall contain a provision on liquidated damages which shall be payable by the contractor in case of breach thereof. For the procurement of goods, infra projects and consulting services, the amount of the liquidated damages shall be at least equal to 1/10 of 1% of the cost of the unperformed portion for every day of delay. Once the cumulative amount of liquidated damages reaches 10% of the amount of the contract, the Procuring Entity may rescind or terminate the contract, without prejudice to other courses of action and remedies available under the circumstances.

## **13. COMPLIANCE TO RA 9184 AND ITS IRR**

The winning bidder shall comply accordingly with the Republic Act 9184 also known as Government Procurement and Reform Act and its Implementing Rules and Procedures (IRR).
