**DECLARING FAILURE OF BIDDING AND RECOMMENDING THE RE-BID FOR THE
MULTI- YEAR MAINTENANCE AND SUPPORT SERVICES FOR THE NROSS SYSTEM**

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Multi-Year Maintenance and Support Services for the NRoSS System with an Approved Budget for the Contract (ABC) of One Hundred Two Million Three Hundred Eighty Eight Thousand Four Hundred Ninety Seven Pesos (PHP102,388,497.00), inclusive of all applicable taxes;

WHEREAS, on March 22, 2023 the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and the BTr website;

WHEREAS, on March 30, 2023, during the scheduled Pre-Bidding Conference, two (2) prospective bidders, namely Radenta Technologies Inc., and the joint venture of Montran Corporation and Allcard, Inc. attended;

WHEREAS, on April 12, 2023, no bidder submitted its bids and participated in the Opening of Bids thus, the BAC is constrained to declare a failure of bidding for the Multi-Year Maintenance and Support Services for the NRoSS System;

NOW THEREFORE, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

- a. declare failure of bidding for the Multi- Year Maintenance and Support Services for the NRoSS System;
- b. recommend for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE) the foregoing findings; and
- c. conduct re-bidding of this project.
