#### **RESOLUTION NO. 10 - 2023**

DECLARING FAILURE OF BIDDING AND RECOMMENDING THE RE-BID FOR THE SUPPLY AND INSTALLATION OF 1 YEAR LICENSES AND SUPPORT TO EXISTING BANDWIDTH MANAGER AND APPLICATION MONITORING SYSTEM OF BTR / ITB-21-2023-G

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee, invited prospective bidders to apply for eligibility and to bid for the Supply and Installation of 1 Year Licenses and Support to Existing Bandwidth Manager and Application Monitoring System of BTr with an Approved Budget for the Contract (ABC) of One Million Seven Hundred Forty Three Thousand Pesos (PHP 1,743,000.00), inclusive of all applicable taxes;

**WHEREAS**, on September 4, 2023, the Invitation to bid was posted through the Philippine Government Electronic Procurement System (PhilGEPS) and the BTr website:

**WHEREAS**, on September 12, 2023, during the scheduled Pre-Bidding Conference, one (1) prospective bidder, namely, Secur Links Network and Technologies, Inc. attended and purchased the bidding documents;

WHEREAS, on September 25, 2023, during the scheduled Opening of Bids, Secur Links Network and Technologies, Inc., submitted its bid, however, during the opening of its Technical Bid, Secur Links Network and Technologies, Inc., failed to comply with the requirements due to the non-submission of the following requirements: 1) Section VI. Schedule of Requirements; 2) Section VII. Technical Specifications; 3) Project Reference Number for the Bid Securing Declaration refers to ITB-3-2023-G (EPA) instead of ITB-21-2023-G; and 4) the submitted Audited Financial Statement for the year 2022 does not indicate any date of receipt by the Bureau of Internal Revenue (BIR);

WHEREAS, after due consideration and deliberation, the BAC is constrained, and thus, resolved to declare a failure of bidding for the Supply and Installation of 1 Year Licenses and Support to Existing Bandwidth Manager and Application Monitoring System of BTr due to the ineligibility of the bidder during the preliminary examination;

**NOW THEREFORE**, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

 a. declare failure of bidding for the Supply and Installation of 1 Year Licenses and Support to Existing Bandwidth Manager and Application Monitoring System of BTr;



- recommend the re-bid of the Supply and Installation of 1 Year Licenses and Support to Existing Bandwidth Manager and Application Monitoring System of BTr; and
- c. recommend for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE) the foregoing findings.
