**DECLARING FAILURE OF BIDDING AND RECOMMENDING THE RE-BID FOR  
THE SUPPLY AND DELIVERY OF VARIOUS COMPUTER PARTS FOR THE  
UPGRADE OF THE BUREAU OF THE TREASURY'S WORKSTATIONS / ITB-22-  
2023-G**

**WHEREAS**, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Supply and Delivery of various computer parts for the upgrade of the Bureau of the Treasury's workstations with an Approved Budget for the Contract (ABC) of One Million One Hundred Ninety Two Thousand Five Hundred Pesos (PHP 1,192,500.00), inclusive of all applicable taxes;

**WHEREAS**, on September 4, 2023, the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and BTr website;

**WHEREAS**, on September 12, 2023, during the scheduled Pre-Bidding Conference, two (2) prospective bidders, namely, InfoWorX Inc., and Bits of Technology Co. attended but only EFRTechno, Inc. purchased the bidding documents;

**WHEREAS**, on September 18, 2023, Supplemental Bid Bulletin No. 02 - 2023 was issued to modify/amend items in the Bid Documents, in response to the queries and clarifications made during the Pre-Bid Conference;

**WHEREAS**, on September 25, 2023, no bidder submitted its bids and participated in the Opening of Bids, thus, the BAC is constrained to declare a failure of bidding for the Supply and Installation of Various Computer Parts for the Upgrade of the Bureau of the Treasury's Workstations;

**NOW THEREFORE**, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

- a. declare failure of bidding for the Supply and Delivery of various computer parts for the upgrade of the Bureau of the Treasury's workstations;
- b. recommend for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE) the foregoing findings; and
- c. conduct re-bidding of this project.
