DECLARING THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB)
FOR THE ONE (1) YEAR PREVENTIVE MAINTENANCE OF 20TR AIR
HANDLING UNIT (AHU) SERVICING OFFICES OF THE BUREAU OF THE
TREASURY AT THE PALACIO DEL GOBERNADOR BUILDING FOR FY 2021

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the One (1) Year Preventive Maintenance of 20Tr Air Handling Unit (AHU) Servicing Offices of the Bureau of the Treasury at the Palacio del Gobernador Building for FY 2021 with an Approved Budget for the Contract (ABC) of Two Million Pesos (Php2,000,000.00), inclusive of all applicable taxes;

WHEREAS, on December 2, 2020, the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and BTr website;

**WHEREAS**, on December 9, 2020, two (2) prospective bidders, namely, 1) Renphil Trading and 2) Urbes Corporation attended the Pre-bid Conference;

WHEREAS, on December 21, 2020, Renphil Trading, the lone bidder, participated in the bidding;

WHEREAS, pursuant to Resolution No <u>0 6</u> - 20<u>2 1</u> dated December 21, 2020, the BAC declared Renphil Trading as the Single Calculated Bidder (SCB) and was subjected to Post-Qualification;

WHEREAS, the Technical Working Group (TWG) submitted their post qualification report which the BAC, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by Renphil Trading found the same to be responsive and thereafter, declared Renphil Trading as the Single Calculated and Responsive Bidder (SCRB);

**NOW THEREFORE**, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

- a. declare Renphil Trading as the Single Calculated and Responsive Bidder (SCRB) for the One (1) Year Preventive Maintenance of 20Tr Air Handling Unit (AHU) Servicing Offices of the Bureau of the Treasury at the Palacio del Gobernador Building for FY 2021;
- b. recommend the award for the One (1) Year Preventive Maintenance of 20Tr Air Handling Unit (AHU) Servicing Offices of the Bureau of the Treasury at the Palacio del Gobernador Building for FY 2021 for the Contract Price of ONE



MILLION NINE HUNDRED FORTY THOUSAND PESOS (Php1,940,000.00), inclusive of all applicable taxes; and

c. recommend for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE) the foregoing findings.
