DECLARING THE LOWEST CALCULATED AND RESPONSIVE BIDDER (LCRB) FOR THE SUPPLY AND INSTALLATION TO EXISTING BACKUP SYSTEM FOR THE BUREAU OF THE TREASURY DATA CENTER OPERATIONS / ITB-1-2023-G (EPA)

WHEREAS, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Supply and Installation to existing backup system for the Bureau of the Treasury Data Center Operations with an Approved Budget for the Contract (ABC) of One Million Four Hundred Twenty-Four Thousand Pesos (Php1,424,000.00), inclusive of all applicable taxes;

WHEREAS, on November 23, 2022, the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and BTr website;

WHEREAS, on December 1, 2022, two (2) prospective bidders, namely, 1) Integrated Computer Systems, Inc. and 2) Infobahn Communications, Inc. attended the Pre-bid Conference;

WHEREAS, Integrated Computer Systems, Inc. and Infobahn Communications, Inc., submitted their Technical and Financial Bids on December 9, 2022 and December 12, 2022, respectively;

WHEREAS, pursuant to Resolution No.48- 2022 dated December 13, 2022, the BAC declared Integrated Computer Systems, Inc. as the Lowest Calculated Bidder (LCB) and was subjected to Post-Qualification;

WHEREAS, the Technical Working Group (TWG) submitted their post qualification report which the BAC, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by Integrated Computer Systems, Inc. found the same to be responsive and thereafter, declared Integrated Computer Systems, Inc. as the Lowest Calculated and Responsive Bidder (LCRB);

NOW THEREFORE, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

a. declare Integrated Computer Systems, Inc. as the Lowest Calculated and Responsive Bidder (LCRB) for the Supply and Installation to existing Backup System for the Bureau of the Treasury Data Center Operations;

- recommend the award for the Supply and Installation to existing backup system for the Bureau of the Treasury Data Center Operations for the Contract Price of One Million One Hundred Sixty-Five Thousand Nine Hundred Ninety-One Pesos (PHP1,165,991.00), inclusive of all applicable taxes; and
- c. recommend for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE) the foregoing findings.
