**RESOLUTION NO. 68 - 2022**

**DECLARING THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB)  
FOR THE SUPPLY AND INSTALLATION OF ONE (1) YEAR LICENSE TO  
EXISTING FIREWALLS AND TRAFFIC AND THREAT ANALYZER OF THE  
BUREAU OF THE TREASURY / ITB-2-2023-G (EPA)**

**WHEREAS**, the Bureau of the Treasury (BTr), through the Bids and Awards Committee (BAC), invited prospective bidders to apply for eligibility and to bid for the Supply and Installation of One (1) Year License to Existing Firewalls and Traffic and Threat Analyzer of the Bureau of the Treasury with an Approved Budget for the Contract (ABC) of Four Million Pesos (PHP4,000,000.00), inclusive of all applicable taxes;

**WHEREAS**, on November 23, 2022, the Invitation to Bid (ITB) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) and BTr website;

**WHEREAS**, on December 1, 2022, four (4) prospective bidders, namely, 1) Infobahn Communications, Inc., 2) Integrated Computer Systems, Inc., 3) One Depot, Inc. and 4) Universal Access and Systems Solutions Philippines Inc. attended the Pre-bid Conference;

**WHEREAS**, on December 13, 2022, only Infobahn Communications, Inc., submitted its Technical and Financial Bids, which, was opened, read, and calculated;

**WHEREAS**, pursuant to Resolution No. 49- 2022 dated December 13, 2022, the BAC declared Infobahn Communications, Inc. as the Single Calculated Bidder (SCB) and was subjected to Post-Qualification;

**WHEREAS**, the Technical Working Group (TWG) submitted their post qualification report which the BAC, after a holistic review, examination, validation and verification of all statements made and the legal, technical, financial documents submitted by Infobahn Communications, Inc. found the same to be responsive and thereafter, declared Infobahn Communications, Inc. as the Single Calculated and Responsive Bidder (SCRB);

**NOW THEREFORE**, the Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVES** to:

- a. declare Infobahn Communications, Inc. as the Single Calculated and Responsive Bidder (SCRB) for the Supply and Installation of One (1) Year

License to Existing Firewalls and Traffic and Threat Analyzer of the Bureau of the Treasury;

- b. recommend the award for the Supply and Installation of One (1) Year License to Existing Firewalls and Traffic and Threat Analyzer of the Bureau of the Treasury for the Contract Price of Three Million Nine Hundred Eighty-Eight Thousand Nine Hundred Eighty Pesos (PHP3,988,980.00), inclusive of all applicable taxes; and
- c. recommend for the approval of the Treasurer of the Philippines as Head of the Procuring Entity (HOPE) the foregoing findings.
